DISCUSSION/ACTION ITEMS

At the request of Authority Staff, the Authority will discuss Assembly Bill No. 175 and Assembly Bill No. 176 of the 78th (2015) Nevada Legislative Session and the possibility of applications for tariff modifications for the 3% excise tax on transportation, whether to treat the tax as a pass through expense, whether noticing is required, and if all carriers who submit by a specified date can share in the cost of noticing, if applicable. Staff investigation concluded.

Senior Deputy Attorney General Newton read the verbiage the Department of Taxation submitted to Legislative Counsel Bureau. Kimberly Maxson-Rushton, Esquire appeared on behalf of the Livery Operators Association and offered a statement with regard to the 3% tax. A lengthy discussion ensued with regard to how to treat the 3% tax and submission of tariff modifications. Commissioner Sakelhide made the suggestion this be remanded back to staff for an interim proposal. It was determined language from Section 36 (or Section 37 if a taxicab) of SB 175 to be used for interim tariff modifications. Applications Manager Liz Babcock requested that any interim modifications be submitted on a single page. Approved 3-0
