**107.** The Authority will discuss and consider approval for the issuance of a draft letter prepared by Chairman MacKay to certificated tow carriers regarding discussion item number 114 from the Authority's December 2014 General Session.

*Chairman MacKay indicated he would be drafting a letter to include the following:*

*1) All tows initiated by the request of a law enforcement officer following an accident or theft recovery remain subject to NRS 706.4489 regardless of whether the resulting tow could be deemed a consent or nonconsent tow; 2) Tow carriers cannot solicit vehicle owners to divert tows to other than the designated lot in contravention of the compulsion of NRS 706.4489; 3) Tow carriers are under no obligation to make any effort to independently investigate or attempt to determine the insurance carrier; 4) Carriers are required to maintain documentation related to tows performed under NRS 706.4489, including notification of the insurer of the vehicle.*
