Commissioner Sakelhide emphasized those concerns. Commissioner Assad moved to remand the matter to Staff for hearing. Motion to remand for hearing approved 3-0.

Chairman Wilkinson summarized the request. Commissioner Sakelhide noted that Staff will monitor any operational changes that may result from reorganization. Approved 3-0.

Chairman Wilkinson noted the obligation to carefully monitor carriers in this status. Approved 3-0.

Applications Manager Babcock noted the number of other carriers utilizing a variant of "VIP" in their dba names. Staff expressed support for the Petition, noted that the carrier's logo is sufficiently distinctive to avoid confusion with other carriers. Approved 3-0.

# PETITION TO DEVIATE FROM REGULATION

**51. Docket 16-01032** – The Authority will consider the Petition of Umbrella Enterprises, LLC dba Umbrella Movers to deviate from NAC 706.208, with respect to the limitation on the proportion of leased versus owned vehicles in the carrier's fleet.

Brent Carson, Esq. and owner Kathryn Ridge were present on behalf of the Applicant. Commissioner Sakelhide voiced a concern about an open-ended approval. The Applicant described the business operation. Authority Staff expressed no concerns. Approved 3-0 for six months from the date of issuance of the Authority's final Order.

Mr. Mezher was present. Commissioner Sakelhide moved to reduce the fine to \$200.00, the amount already paid. Approved 3-0.

**58. Docket 16-01025**. Petitioner Stephen Johnson seeks to be removed from the ineligible driver list.

Mr. Johnson was present. Staff confirmed that Mr. Johnson has now paid all fine amounts. Approved 3-0.

**59. Docket 16-01034.** Petitioner Jason Shandi seeks reconsideration of the Authority's October 2014 final Order in the matter of Citation 17203. (GA)

Mr. Shandi was present and described the circumstances of his case. Matter re-opened for limited rehearing on fine amounts by a vote of 3-0. Mr. sahnsi

# **SETTLEMENT OFFERS**

- 60. The Authority will consider Respondent Byron Ochoa's offer in compromise of the outstanding fine amounts owed for Impound TA 150320-079 and Citations TA 8-00040143 TA 8-00040680. Mr. Day summarized the request and SDAG Newton expressed support for the proposal. By a vote of 3-0, the Authority approved the agreement, with direction to notify Controller's Office that the Authority retains pursuant to NRS 706.772(2)(b)(2) the ability to seek suspension of the Respondent's driver's license if he fails to comply with terms of a payment agreement.
  - **61.** The Authority will consider Respondent A. Robert Fairman's offer in compromise of the outstanding fine amounts owed for Citation 14473.

The Respondent was not present. Commissioners Assad and Sakelhide expressed concern about any settlement for a mere 10 cents on the dollar. Commissioner Sakelhide also noted that the Respondent had made no payments toward the fine amount. Commissioner Sakelhide suggested a response to the Controller's Office that the Authority finds the offer of 10 cents on the dollar unacceptable. The Authority authorized Commissioner Sakelhide proposal by a vote of 3-0.

# **FINANCIAL RATES AND TARIFFS**

**62. Docket 15-12038** The Application of Lewis Carriages, Inc. d/b/a All Resort Limousine for approval of a tariff rate modification for services conducted under CPCN 1125. Staff investigation concluded.

John Harrick was present on behalf of the Applicant. Financial Analyst Lidia Aronova summarized the Application, expressing support but for the logistic fee. Mr. Harrick fielded questions from the Commissioners, primarily focused on the logistics fee. Approved 3-0.

**63. Docket 16-01021** The Application of Pink Jeep Tours of Las Vegas, Inc. d/b/a Pink Jeep Tours for approval of a tariff rate modification for services conducted under CPCN 1078, Sub 1. Staff investigation concluded.

Kimberly Maxson-Rushton, Esq. was present on behalf of the Applicant and responded to a question from Chairman Wilkinson regarding the impetus for the proposed changes. Approved 3-0.

**64. Docket 16-01022** The Application of A. A. Action Towing, Inc. d/b/a Action Towing for approval of a tariff rate modification for services conducted under CPCN 3336, Sub 1. Staff investigation concluded.

Rosalee Dillon was present on behalf of the Applicant and explained the request. Approved 3-0.

**65. Docket 16-02002** The Application of Umbrella Enterprises, LLC d/b/a Umbrella Movers for approval of a tariff rate modification for services conducted under CPCN 3364. Staff investigation concluded.

Brent Carson, Esq. and owner Kathryn Ridge were present on behalf of the Applicant. Commissioner Sakelhide voiced a concern about whether the proposed tariff would still support the Application, which was recently approved based upon different tariff rates.

Owner Tamu Seman and James S. Kent, Esq. were present on behalf of the Applicant. Kimberly Maxson-Rushton was present on behalf of the Intervener. Mr. Kent requested elimination of the restrictions on expansion within two years and on accepting Kelly business. Ms. Rushton expressed support for the proposed restrictions. Approved 3-0 as proposed.

**67. Docket 16-01010** The temporary discontinuance from January 12, 2016 through June 30, 2016 of household goods moving services provided by Big Box Storage Nevada, Inc. d/b/a Peoples Moving & Storage under CPCN 3342, Sub 2. Staff investigation concluded. *Approved 3-0*.

# <u>APPLICATIONS FOR TRANSPORTATION NETWORK COMPANY PERMITS</u>
