Adam's Transportation, LLC d/b/a Lucky 7's has filed an application, designated as Docket 16-07039 with the Nevada Transportation Authority ("Authority") for a Certificate of Public Convenience and Necessity ("CPCN") to provide charter bus service within the State of Nevada.

D & J VIP, LLC d/b/a Triple Seven 777 Transport has filed an application, designated as Docket 16-07040 with the Authority for a CPCN to provide charter bus service within the State of Nevada.

David Daneshforooz, Gerald R. Hoist, Jr. and David R. Otero ("Applicants") have filed a joint application designated as Docket 16-07041 with the Authority for authority by David Daneshforooz to sell and transfer and Gerald R. Hoist, Jr. and David R. Otero to purchase and acquire 100% of the stock of Starlight Limousine, Inc., d/b/a Entourage Transportation, a carrier authorized to provide charter bus service within the State of Nevada granted under CPCN 2158, Sub 1. This application may include tariff modifications.

A Blue Sky Towing and Transportation, LLC has filed an application, designated as Docket 16-08004 with the Authority for a CPCN to provide consent-only tow car service by tow car vehicle within the State of Nevada.

Vegas Lambo Tour, LLC has filed an application, designated as Docket 16-08005 with the Authority for a CPCN to provide scenic tour service within Clark County, Nevada. The Applicant has requested that certain information be kept confidential.

Smitty Movers, LLC ("Applicant") has filed an application, designated as Docket 16-08007 with the Authority seeking to expand their authority for household goods moving granted under CPCN 3354. The Applicant seeks to increase their current vehicle limitation of from no more than two (2) vehicles to a limit of no more than five (5) vehicles in their fleet.

Safeco Parking & Transportation Services, LLC has filed an application, designated as Docket 16-08008 with the Authority for a Contract Carrier Permit to provide transportation services pursuant to contracts with Desert Blue Unit-Owners Association, Inc. and Worldmarke Unit-Owners Association, Inc. within the State of Nevada. The Applicant has requested that certain information be kept confidential.

The applications were filed pursuant to Chapter 706 of the NRS and the Nevada Administrative Code ("NAC"). Under NRS 706.151, the Authority has legal jurisdiction and authority over these matters.

Persons with a direct and substantial interest in the filings may file Petitions for Leave to Intervene at the Authority's office. Such Petitions must conform to the Authority's regulations and must be filed on or before September 12, 2016.
