RVNB Holdings, LLC (“RVNB”) and AMS Group Holdco, LLC (“AMS Group”) (together “Applicants”) have filed a Joint Application designated as Docket 17-09039 with the Authority for authority for RVNB to sell and transfer and AMS Group to purchase and acquire All My Sons Moving and Storage of Las Vegas, LLC, a carrier authorized to provide household goods moving service granted under CPCN 3256, Sub 2, within the State of Nevada. The Applicants have requested that certain information be kept confidential. This Application may include tariff modifications.

The applications were filed pursuant to Chapter 706 of the Nevada Revised Statutes (“NRS”) and the Nevada Administrative Code (“NAC”). Under NRS 706.151, the Authority has legal jurisdiction and authority over these matters.
