**NOTICE OF HEARING**

Las Vegas Transportation doing business as 24/7 Las Vegas Transportation has filed an application to sell and transfer and for 24/7 Limousines, Ltd., doing business as 24/7 Limousines to purchase and acquire Certificate of Public Convenience and Necessity ("CPCN") No. 1065. The Authority's records show that Applicant holds CPCN 1065 sub 2.2. CPCN 1065 sub 2.2 authorizes service as follows:

TEMPORARY: On-call over irregular routes for the transportation of passenger[s] and their baggage in charter limousine service between points and places in Clark County and Nye County, Nevada.

**RESTRICTIONS:**

The number of vehicles in the carrier's fleet shall be no more than fourteen (14).

All vehicles are to be equipped with a ramp or lift system to facilitate the transportation of automated motor scooter/power chairs and wheelchairs.

Each ramp or lift system must be well maintained and in proper working order.

All drivers are to be trained in the use of ramp and lift systems used to facilitate the transportation of automated motor scooter/power chairs and wheelchairs.

Carrier shall include in Yellow Pages and Internet advertising reference to capability to transport automated motor scooter/power chairs and wheelchairs.

***Temporary authority in effect until September 22, 2018 or until the Authority orders otherwise, whichever comes first.***

The application was filed pursuant to Nevada Revised Statutes (“NRS”), Chapter 706, Nevada Administrative Code (“NAC”), Chapter 706, NRS 706.6411, and NAC 706.1375. The Authority has jurisdiction over this application pursuant to NRS 706.6411.
