**NOTICE OF APPLICATIONS and REQUESTS FOR TARIFF MODIFICATIONS FOR
THE 2024 SUPER BOWL SPECIAL EVENT**

Seiji, LLC., d/b/a Seiji Limousine, d/b/a Winner Limousine filed an application, designated as Docket No. 23-12004-J, with the Authority requesting a temporary expansion of its fleet by 5 vehicles for its charter limousine authority granted under Certificate of Public Convenience and Necessity (CPCN) 1111, Sub 4. The carrier also requested approval of a tariff modification. The requested expansion and tariff modification will occur between January 29, 2024 and February 14, 2024 for the sole purpose of providing transportation during the 2024 Super Bowl Special Event.

Five Star Limo, LLC. d/b/a. filed an application, designated as Docket No. 23-12004-K, with the Authority requesting a temporary expansion of its fleet by 1 vehicle for its charter limousine authority granted under CPCN 1113, Sub 3. The requested expansion will occur between January 29, 2024 and February 14, 2024 for the sole purpose of providing transportation during the 2024 Super Bowl Special Event.

BLS Limousine Service of Las Vegas, Inc. filed an application, designated as Docket No. 23-12004-M, with the Authority requesting a temporary expansion of its fleet by 6 vehicles for its charter limousine authority granted under CPCN 1070, Sub 3. The carrier also requested approval of a tariff modification. The requested expansion and tariff modification will occur between January 29, 2024 and February 14, 2024 for the sole purpose of providing transportation during the 2024 Super Bowl Special Event.

Omni Limousine, Inc. filed an application, designated as Docket No. 23-12004-N, with the Authority requesting a temporary expansion of its fleet by 15 vehicles for its charter limousine authority granted under CPCN 1084, Sub 5. The carrier also requested approval of a tariff modification. The requested expansion and tariff modification will occur between January 29, 2024 and February 14, 2024 for the sole purpose of providing transportation during the 2024 Super Bowl Special Event.

The applications and tariff modification requests were filed pursuant to Chapter 706 of the NRS and the Nevada Administrative Code (“NAC”). Under NRS 706.151, the Authority has legal jurisdiction and authority over these matters.

The applications and tariff modification requests are on file and available for viewing at the office of the Authority, 3300 W. Sahara Avenue, Suite 200, Las Vegas, Nevada 89102.

Persons with a direct and substantial interest in the above noted filings may file Petitions for Leave to Intervene at the Authority’s office. Such Petitions must conform with the Authority’s regulations and must be filed **on or before January 29, 2024**.

Interested persons may submit Protests for filing at the Authority’s offices. Protests must also conform with the Authority’s regulations. Other written comments may also be submitted for filing.
