The Transportation Services Authority of Nevada finds that the above-named carrier has complied with this Authority's Compliance Order dated July 22, 1998, the findings of fact and conclusions of law which are hereby incorporated by this reference, and therefore is entitled to receive authority from this Authority to engage in transportation in intrastate commerce as a motor carrier.

IT IS ORDERED that a certificate of public convenience and necessity PSC 3066, Sub 1, formerly issued to Barry E. Jones CARSON VALLEY MOVERS is hereby CANCELED and that in lieu thereof this certificate CPCN 3066, Sub 2, is hereby issued to Barry E. Jones dba CARSON VALLEY MOVERS.

IT IS FURTHER ORDERED that Barry E. Jones dba CARSON VALLEY MOVERS is hereby granted this certificate of public convenience and necessity as evidence of the authority of the holder to engage in transportation in intrastate commerce as a common carrier by motor vehicle subject to applicable statutes and rules and regulations of the Authority, and such terms, conditions and limitations as are now or may hereafter be attached to the exercise of the privileges herein granted.

IT IS FURTHER ORDERED and made a condition of this certificate that the holder shall render reasonably continuous and adequate service to the public in pursuance of the authority herein granted, and that failure to do so shall constitute sufficient grounds for suspension, modification or revocation of this certificate.

IT IS FURTHER ORDERED that nothing contained herein shall be construed to be either a franchise or irrevocable and that failure to comply with rules, regulations and orders of the Authority and applicable statutory provisions shall constitute sufficient grounds for suspension or revocation of this certificate.

IT IS FURTHER ORDERED that this authority shall not be sold or transferred without the Authority's prior approval.

IT IS FURTHER ORDERED that the transportation service to be performed by said carrier shall be as specified below:

On-call irregular route transportation of household goods between all points and places in Nevada.

**EXCEPT:**

Carrier is restricted from operating between all points and places within Clark County, Nevada until July 1, 2000; and

Carrier is restricted to operating five (5) power units within Clark County, Nevada; and


Carrier is restricted from establishing any equipment points within Clark County or Washoe County, Nevada until July 1, 2000.

IT IS FURTHER ORDERED that the Authority retains jurisdiction for the purpose of correcting any errors which may have occurred in the drafting or issuance of this Order and Certificate of Public Convenience and Necessity.
