and
CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

The Nevada Transportation Authority ("Authority") finds that the above-named carrier has complied with this Authority's Compliance Order dated November 20, 2008, the findings of fact and conclusions of law which are hereby incorporated by this reference, and therefore is entitled to receive authority from this Authority to engage in transportation in intrastate commerce as a motor carrier.

IT IS ORDERED that Bobcat Tours, Inc. is hereby granted this certificate of public convenience and necessity as evidence of the authority of the holder to engage in transportation in intrastate commerce as a common carrier by motor vehicle subject to applicable statutes, rules and regulations of the Authority, and such terms, conditions and limitations as are now or may hereafter be attached to the exercise of the privileges herein granted.

IT IS FURTHER ORDERED and made a condition of this certificate that the holder shall render reasonably continuous and adequate service to the public in pursuance of the authority herein granted, and that failure to do so shall constitute sufficient grounds for suspension, modification or revocation of this certificate.

IT IS FURTHER ORDERED that nothing contained herein shall be construed to be either a franchise or irrevocable and that failure to comply with rules, regulations and orders of the Authority and applicable statutory provisions shall constitute sufficient grounds for suspension or revocation of this certificate.

IT IS FURTHER ORDERED that this authority shall not be sold or transferred without the Authority's prior approval.

IT IS FURTHER ORDERED that the transportation service to be performed by said carrier shall be as specified below:

On-call irregular route transportation of passengers utilizing four-wheel drive vehicles with carrying capacity of nine passengers or less. Including the driver, equipped for off-road travel, in the Las Vegas area.

Tours shall proceed via Interstate 15 to Route 160, West on Route 160, then exit off-road into the desert using Bureau of Land Management (BLM) trails off-road in the Black Velvet Canyon area, and such other off-road tours as designated by Bobcat Tours and approved by the appropriate governing authority, (BLM).

Provide Scenic Tours into desert areas, on trails (unimproved and unpaved roadways) approved by the BLM as defined by NAC 706.112.

RESTRICTIONS:


Vehicles utilized in the service shall have adequate signage identifying the company as an off-road scenic tour company. All trips and /or tours must contain a significant portion of travel off-road, on unimproved and unpaved roadways or trails and that portion of off-road travel will occur in the middle of the trip/tour. The use of paved roads in the greater Las Vegas and Henderson, Clark County areas will only be for the purpose of transporting the vehicle and its passengers to and from an off-road tour.

Tours of Clark County are not to include the casino/hotel areas, including, but not limited to, the Las Vegas Strip (Las Vegas Boulevard) and the Fremont Street Experience, except to pick up and drop off passengers.

No passengers are to be picked up or dropped off at McCarran International Airport.

IT IS FURTHER ORDERED that the Authority retains jurisdiction for the purpose of correcting any errors which may have occurred in the drafting or issuance of this Order and Certificate of Public Convenience and Necessity.
