CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

The Nevada Transportation Authority ("Authority") finds that the above-named carrier has complied with this Authority's Amended Compliance Order dated March 24, 2016, the findings of fact and conclusions of law which are hereby incorporated by this reference, and therefore is entitled to receive authority from this Authority to engage in transportation in intrastate commerce as a motor carrier.

IT IS ORDERED that certificate of public convenience and necessity identified as CPCN 1217, Sub 1, is hereby cancelled and Platinum LV Transportation, LLC d/b/a Bell Limo is hereby granted this certificate of public convenience and necessity, identified as CPCN 1217, Sub 2, as evidence of the authority of the holder to engage in transportation in intrastate commerce as a common carrier by motor vehicle subject to applicable statutes, rules and regulations of the Authority, and such terms, conditions and limitations as are now or may hereafter be attached to the exercise of the privileges herein granted.

IT IS FURTHER ORDERED and made a condition of this certificate that the holder shall render reasonably continuous and adequate service to the public in pursuance of the authority herein granted, and that failure to do so shall constitute sufficient grounds for suspension, modification or revocation of this certificate.

IT IS FURTHER ORDERED that nothing contained herein shall be construed to be either a franchise or irrevocable and that failure to comply with rules, regulations and orders of the Authority and applicable statutory provisions shall constitute sufficient grounds for suspension or revocation of this certificate.

IT IS FURTHER ORDERED that this authority shall not be sold or transferred without the Authority's prior approval.

IT IS FURTHER ORDERED that the transportation service to be performed by said carrier shall be as specified below:

Common carrier, on call, over irregular routes transporting passengers and their luggage in chauffeured limousine service between Reno/Tahoe International Airport and hotels and motels in Reno and Sparks, Nevada and a 5-mile radius thereof.

Common carrier, on call, over irregular routes transporting passengers and their luggage in uniformed chauffeured limousine service between points and places within an area encompassed by the boundaries of Washoe, Douglas, and Storey Counties and Carson City, Nevada and between points and places within the above-described area on the one hand and, on the other, points and places in Nevada.

(At no time shall the certificate holder publish a per capita tariff for the service to be rendered in paragraph 2).

IT IS FURTHER ORDERED that the Authority retains jurisdiction for the purpose of correcting any errors which may have occurred in the drafting or issuance of this Order and Certificate of Public Convenience and Necessity.
