

2011 ADDITION TO LIMOUSINE AND TAXICAB DRIVER ELIGIBILITY REGULATIONS

LIST OF PERSONS INELIGIBLE FOR HIRE AS LIMOUSINE OR TAXICAB DRIVER

On December 16, 2010, the NTA amended the provisions of:

NAC 706.229 (Requirements for employee who drives a traditional limousine or livery limousine) and

NAC 706.3751 (Requirements for employee or independent contractor who drives a taxicab).

Beginning on March 1, 2011, individuals who:

- 1) Fail to appear at a hearing before the NTA, resulting in findings of a violation of NRS 706 or NAC 706;
- 2) Are found more than 5 times to be in violation of NRS 706 or NAC 706; or
- 3) Fail to pay any fine assessed to them by the NTA;

are not be eligible for hire as the driver of a charter limousine or a taxicab that operates under the jurisdiction of the NTA.

Following is a list of ineligible drivers. The list is maintained by the NTA and will be updated as necessary.
