EQUIPMENT AND PERSONNEL REQUIREMENT FOR NON-AMBULATORY TRANSPORT

Medic Coach Service shall equip all non-emergency ambulances to be used for carriage of non-ambulatory individuals with the following:

EQUIPMENT

Vehicles used shall be specially designed to accommodate and carry the following minimum life saving equipment.

1. Stretcher, 2. Clean Linen, 3. First Aid supplies, 4. Oxygen equipment
5. Airway maintenance equipment and suction, 6. Blood Pressure Cuff and Stethoscope, 7. Hand operated bag-mask ventilation unit.

PERSONAL

Each non-emergency ambulance shall use at least two crew members, one of whom has successfully completed training for Emergency Medical Technicians, as licensed in Nevada.

Only vehicles meeting the above equipment and personal requirements may operate as non-emergency ambulances, designed and operated exclusively for such carriage of Medicare Beneficiaries.



WAIT TIME CHARGE: Wait time will be an additional charge based on amount of time spent waiting, in 30-minute blocks. Wait times begin at the time of drop off at appointment or facility. A minimum of 30 minutes wait time will be assessed. Any wait time under 30 minutes will be charged the 30-minute wait time price for the given entity. Wait times will be charged as follows:
