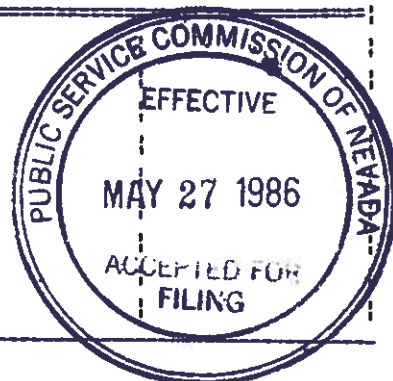

Rule No. | RULES AND REGULATIONS

APPLICATION OF TARIFF

5 Rules, regulations, rates, and charges named in this tariff apply to the transportation of passengers and their baggage between Airports located within Clark County, Nevada, and points and places in Clark County, Nevada, where such traffic may originate or terminate.

BAGGAGE

- (a) Hand baggage not to exceed forty (40) pounds per adult passenger will be permitted.
- 10 (b) No tools or articles with sharp edges will be carried unless securely and safely packaged.
- (c) No explosives, inflammables, or liquids which could contaminate or be harmful to passengers or equipment will be carried.

ANIMALS

15 Dogs, cats, or other live animals will not be carried unless properly confined in an approved container.
Exception: Seeing-Eye dogs in the performance of their duty guiding blind persons.

OBJECTIONABLE PERSONS

20 Carrier reserves the right to refuse transportation to any person under the influence of intoxicants or drugs, of incapable of taking care of himself or herself, or when conduct is likely to be objectionable to other passengers or prospective passengers. This rule does not apply to persons who are ill or incapacitated and are accompanied by an attendant or nurse.

25	<p><u>CHILDREN'S FARES</u></p> <p>Children under five (5) years of age, when accompanied by an adult passenger, and not occupying a seat to the exclusion of other passengers, will be carried without charge. Children under five (5) years of age occupying seats to the exclusion of other passengers will be charged full fare.</p>
30	<p><u>STOPOVER PRIVILEGES</u></p> <p>No stopover privileges will be permitted.</p>
35	<p><u>CARRIER'S LIABILITY</u></p> <p>Carrier will not be liable for loss or damage to baggage or the contents thereof unless occasioned by lack of reasonable care on its part, and then only for the reasonable value thereof, subject to a maximum liability of \$250.00 for the loss of, or damage to, any single piece of baggage, including its contents.</p>
40	<p><u>CLAIMS</u></p> <p>Claims for loss of baggage must be communicated to the carrier at the time the passenger arrives at his/her final destination. The passenger will have 24 hours to submit a supporting written claim. The carrier shall have a reasonable time in which to locate the lost baggage before making settlement, which will be not less than ten (10) days after being notified of such loss. Claims for damage to baggage or contents thereof must be filed in writing with the carrier within ten (10) days after the baggage was delivered to the customer.</p>
45	<p><u>DEPARTURE</u></p> <p>The departure of a livery limousine from McCarran International Airport may be delayed, at the discretion of the carrier, until a minimum of four fare-paying passengers have boarded, in each instance. In no instance shall departure be delayed more than 15 minutes after the boarding of the first passenger.</p>
*50	<p><u>PRE-ARRANGEMENT</u></p> <p>Fares for airport transfer service utilizing traditional limousines requires either online prepaid purchase of a voucher, for round-trip transportation only, from an authorized online travel wholesaler (e.g. Expedia), or from the Company's website, call center or airport sales booth, prior to the passenger's intended use of the voucher. The voucher must specify the date and time of the purchase. Upon the passenger entering the vehicle, the driver shall collect the prepaid voucher stub from the passenger and make it available for inspection by agents of the Nevada Transportation Authority.</p>

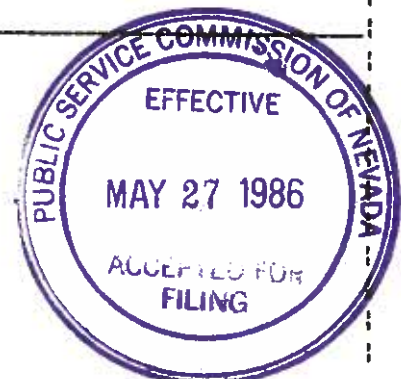
