- A) PASSENGERS WILL NOT BE PERMITTED TO BOARD THE LIMOUSINE WITH FIREARMS (UNLESS THE FIREARM IS DISASSEMBLED, OR UNLOADED IN A CARING CASE), EXPLOSIVES, INFLAMMABLES, OR ANY OTHER ARTICLE OR SUBSTANCE WHICH, IN THE OPINION OF THE DRIVER, COULD BE HARMFUL TO FELLOW PASSENGERS.
- B) PASSENGERS WITH SHARP POINTED TOOLS OR INSTRUMENTS WILL HAVE THEM WRAPPED SECURELY TO PREVENT INJURY OR DAMAGE TO OTHER PASSENGERS OR THE LIMOUSINE.
- C) BAGGAGE IS NOT TO EXCEED FIFTY (50) POUNDS, DOMESTIC AND SEVENTY (70) POUNDS FOR FIRST CLASS INTERNATIONAL, AND ONLY TWO (2) BAGS PER PASSENGER, ADDITIONAL BAGGAGE WILL BE ALLOWED AT THE DRIVERS OPINION.

LIABILITY, LIMITATIONS AND CLAIMS PROCEDURES

- A) CARRIER WILL NOT BE RESPONSIBLE FOR, OR LIABLE TO PASSENGERS, FOR PERSONAL ITEMS OR ARTICLES LOST OR STOLEN FROM PASSENGERS.
- B) CARRIER WILL NOT BE LIABLE FOR LOSS OR DAMAGE TO BAGGAGE, OR THE CONTENTS THEREOF, UNLESS OCCASIONED BY LACK OF DUE CARE ON THE PART OF THE CARRIER OR IT AGENTS, AND IN THE EVENT WILL ONLY BE LIABLE FOR THE REASONABLE VALUE THEREOF, NOT TO EXCEED TWO HUNDRED AND FIFTY DOLLARS (\$250.00), FOR ANY SINGLE PIECE OF BAGGAGE, INCLUDING THE CONTENTS THEREOF.
- C) CLAIMS FOR LOSS OR DAMAGE TO BAGGAGE MUST BE FILED IN WRITING WITH THE CARRIER WITHIN SEVEN (7) DAYS AFTER THE BAGGAGE WAS LEFT IN THE CUSTODY OF THE CARRIER, AND MUST CONTAIN SUFFICIENT INFORMATION REGARDING SUCH LOSS OR DAMAGE TO ENABLE THE CARRIER TO READLY DETERMINE THE BASIS AND THE AMOUNT OF THE CLAIM, AND THE CIRCUMSTANCES WHICH RESULTED IN SUCH LOSS OR DAMAGE. THE CARRIER SHALL NOTIFY THE PASSENGER OF THE SETTLEMENT, OR OTHER DISPOSITION OF THE CLAIM, WITHIN FOURTEEN (14) DAYS OF RECEIPT OF A TIMELY FILED CLAIM. CARRIER RESERVES THE RIGHT TO REQUEST THE SUBMISSION OF ADDITIONAL INFORMATION FROM A PASSENGER REGARDING A CLAIM FOR LOSS OR DAMAGE BEFORE CONSIDERING SUCH AS A TIMELY FILED CLAIM.
- D) A DENIAL OF A CLAIM MAY BE APPEALED BY THE SHIPPER OR CONSIGNOR TO THE TRANSPORTATION SERVICES AUTHORITY.

- 1) THE PRICE OF REGULAR AND DIESEL FUEL IS AS AMOUNT EQUAL TO THE RETAIL PRICE PER GALLON OR REGULAR AND DIESEL FUEL EFFECTIVE FOR THE 25th CALENDER DAY OF THE IMMEDIATELY PRECEDING MONTH DETERMINED ACCORDING TO THE UNITED STATES DEPT OF ENERGY (DOE), ENERGY INFORMATION ADMINISTRATION (EIA) SURVEY ON WEEKLY RETAIL GASOLINE AND DIESEL PRICES. REGULAR GRADE-WEST COAST(PADD 5) AND WEEKLY RETAIL GASOLINE AND DIESEL PRICES, DIESEL, ALL TYPES-WEST COAST(PADD 5). THE PRICES MAY BE OBTAINED BY CALLING THE DOE, EIA AT (202)586-8800 OR VIA THE DOE, EIA WEBSITE AT WWW.EIA.DOE.GOV VIA THE "PETROLEUM" LINK.
- 2) IF THE 25th DAY OF THE CALENDAR MONTH IS A FEDERAL HOLIDAY, THE PRICE WILL BE DETERMINED BASED ON THE DOE PRICE AVAILABLE ON THE NEXT BUSINESS DAY.
- 3) THE DOE FUEL PRICE OBTAINED WILL THEN BE INDEXED BASED ON THE MATRIX SET FORTH BELOW TO DETERMINETHE FUEL SURCHARGE.
