**APPLICATION OF CARRIER'S OPERATIVE RIGHTS**

Fares and charges in this tariff are limited in their applications to the extent of carrier's operating authority set forth in certificate, issued by the Transportation Services Authority in Nevada, RESTRICTED to transportation in INTERSTATE Commerce only as common carrier by motor vehicle, as follows:

DIAMOND TRANSPORTATION, Inc.

On-Call over irregular routes, of Passengers in Charter bus service, between points and within the State of Nevada.

**APPLICATION OF TARIFF**

Fares and charges named in this tariff are stated in gross (commissionable) terms and cover only ground transportation of passengers and their baggage, as provided in Carrier's Operating Authority charter operations. Rates and charges provided in this tariff, for services as ordered, shall be prepaid or paid by established accounts with 30 days of service. Charges for services in addition to the service ordered and previously prepaid shall be paid within 24 hours of presentation of invoice or transportation bill to debtor.

**BAGGAGE**

Hand baggage, not to exceed seventy-five (75) pounds in weight for each fare ticket will be carried without charge. No baggage other than hand baggage will be carried on any trip. Carrier will not be liable for loss or damage to baggage or contents thereof unless occasioned by lack of reasonable care on its part and then only for the maximum liability of \$25.00 for the loss of, or a single piece of baggage, including its contents.

**CHILDREN'S FARES**

Children under three (3) years of age when accompanied by an adult passenger and not occupying a seat to the exclusion of the other passengers, will be carried without charge. Children three (3) years of age occupying seats to the exclusion of other passengers will be charged full fare.

**CLAIMS**

Unless otherwise prescribed by law, all claims of whatsoever character must be filed in writing with carrier within One Hundred Eighty (180) days.

**ANIMALS**

Animals, other than "Seeing Eye Dogs" will not be carried unless properly confined.

**OBJECTIONABLE PERSONS**

The driver of the transit vehicle will have the right to refuse to carry any person or require any passenger to leave the vehicle if the person or passenger is intoxicated, unruly or is believed to be under the influence of narcotics.

**PASSENGER AGENT**

Carrier may elect to appoint as it's agent any organization, firm, corporation, motel, hotel or legal gaming operations, who individually or collectively, desire to obtain passenger bus transportation service between one or more common points for collection of all collectible charges and remittance thereof direct to carrier without individual passenger fare collection by the carrier.
