RULES AND REGULATIONS

1. APPLICATION OF FARES: Transportation of passengers in charter service by limousine, on-call, over irregular routes between points and places within Clark and Nye Counties, Nevada.

2. COMPUTATION OF RATES AND CHARGES: C

Rates and charges in this tariff are applicable to waiting time, and live services, and apply from the time the vehicle is dispatched from its base at 2901 S Highland Dr until passenger drop-off. Add deadhead time and/or out of area to the rates and charges named in this tariff (i.e., require travel of the vehicle without passengers between the point of dispatch and the point of passenger pickup or drop off) except that there will be no charge for deadhead time for the transportation provided entirely within the area of Clark Country hereby designated as Zone1. **ZONE 1; 1 HOUR SERVICE AREA. ZONE 2; 1.5 HOUR SERVICE AREA** will be charged a minimum of one and a half (1 ½ hours which includes the minimum 1 hour charge plus an additional half (.5) hour deadhead time. **ZONE 3; 2 HOUR SERVICE AREA** will be charged a minimum of two (2) hours which includes the 1-hour minimum charge and an additional one (1) hour deadhead time. **ZONE 4; 3 HOUR SERVICE AREA** will be charged a minimum of three (3) hours which includes the 2-hour minimum charge and an additional one (1) hour deadhead time. **ZONE 5; 4 HOUR SERVICE AREA** will be charged a minimum of four (4) hours which includes the 3-hour minimum charge and an additional one (1) hour deadhead time. **ZONE 6; 5 HOUR SERVICE AREA** will be charged a minimum of five (5) hours which includes the 4-hour minimum charge and an additional one (1) hour deadhead time. Services to or from areas outside zone 1, 2, 3, 4, 5 and 6 (Clark County) will be charged a 6 hour minimum charge which includes an additional one hour of dead head time. All Zone descriptions can be found on Page 7.

3. BAGGAGE: C Hand baggage, not to exceed sixty pounds in weight for each fare will be carried without charge. No baggage other than hand baggage will be carried on any trip. (a) Carrier will not be liable for loss or damage for contents thereof unless occasioned by lack of responsible care on its part and only in accordance with Rule 5 herein, (b) Articles with sharp edges, oversized baggage, or that which might otherwise damage the vehicles will not be carried unless securely and safely packaged. (c) Explosives, inflammables, or harmful liquids will not be transported. (d) Excess baggage other than hand baggage may be carried in an additional vehicle to be supplied by the Carrier at the rates and charges listed on Page 6 herein.

4. CANCELLATION: (a) **FEDERAL HOLIDAYS & SPECIAL EVENTS:** Earth Limos requires a 7-day cancellation policy for all Federal Holidays & Special Events (defined on Page 8). For Federal Holidays & Special Events, the carrier will charge a 50%, non-refundable deposit on all transportation reservations. The cancellation fee shall be the entire deposit, unless request is cancelled more than 7 days from departure destination; **N** In the event that your cancellation occurs prior to the required 7 days, we will return 90% of your deposit. The remaining 10% will be used to cover all processing fees. (b.) **NON FEDERAL HOLIDAYS & SPECIAL EVENTS:** All other cancellations require a notice of cancellation not less than twenty-four (24) hours prior to the departure time originally agreed upon for vehicle types **C** 3 & 6-14 listed on Page 4, section 8 and a one (1) hour cancellation for vehicles types **C** 1, 2, 4, & 5 listed on Page 4, section 8. If notice of cancellation is not timely for the appropriate vehicle type, a charge equal to the minimum charge for the service originally requested will be charged by the carrier. **N** In the event that your cancellation occurs prior to the 24 hours or 1 hour (depending on the corresponding vehicle), we will return 90% of the charge equal to the minimum charge for the service originally requested. The remaining 10% will be used to cover all processing fees.

5. CARRIER'S LIABILITY, LIMITATIONS, AND CLAIM PROCEDURE: NAC 706.333 Claims for lost or damaged freight or baggage. (NRS 706.171)

- 1. A claim by a shipper or consignor against a common or contract motor carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered.
- 2. Within 14 days after receipt of the claim, the carrier shall:
 - (a) Compensate the shipper or consignor; or
 - (b) Deliver to the shipper or consignor a written denial of the claim.
- 3. A denial of a claim may be appealed by the shipper or consignor to the Authority.
(Added to NAC by Pub. Service Comm'n, eff. 9-1-87; A by Transportation Serv. Auth. by R071-98,10-28-98)

6. DAMAGE TO VEHICLES: Each vehicle dispatched for a charter will be in good condition upon arrival. Any damage to the vehicle which is caused by the charter customer(s) will be charged by the Carrier to the customer(s) per item:

7. CONTINUOUS CHARTER PROVISION: When a customer requests transportation requiring to be dropped off and then picked up again within 90 minutes of the drop off time for service in Zone 2 or Zone 3, the trip will be considered as one continuous charter and the customer will be charged for the interim waiting time.

9. REFUSAL TO CARRY PERSONS OR PASSENGERS: The driver of the transit vehicle shall have the right to refuse to carry any person or require any passenger to leave the vehicle if the person or passenger is intoxicated, unruly, is believed to be under the influence of narcotics, is believed to present a danger to the health or safety of the driver, or if verbal threats of any kind are made toward any staff member

If a passenger vomits or spills liquids inside the car or defaces the vehicle, Customer is required to pay a \$500.00 cleanup fee

10. ANIMALS: Animals, other than "Seeing Eye Dogs" and other dogs assisting handicapped customers, will not be carried unless properly confined.

11. LIABILITY: The carrier will not be liable for delays caused by an Act of God, public enemies, terrorism, authority of law, quarantine, perils of navigation, riots, strikes, traffic delays, and hazards or dangers incident to a state of war, accidents, breakdowns, bad road conditions, storms, and other conditions beyond its control, and does not guarantee arrival or departure from any point at a specified time. The Carrier will endeavor to maintain the schedule in the charter order but the same is not guaranteed. If any of the above actions occur and make it, in the sole opinion of the Carrier, inadvisable to operate a vehicle either from the place of origin or any point en route, the Carrier shall not be liable therefore, or be caused to be held for damages for any reason whatsoever. Earth Limos is not responsible for lost or stolen articles that were left on, in, or around our vehicles. It is the parties' responsibility to monitor all of their belongings.

12. PASSENGER AGENT: Carrier may select to appoint as its agent any organization, firm, corporation, motel, hotel, or legal gaming operation, who individually or collectively, desire to obtain passenger transportation service between one or more common points for the collection of all applicable charges and remittance thereof direct to carrier without individual passenger fare collection by the carrier

13. COMMISSION OR REFERRAL FEE: Carrier may pay a commission or referral fee to a travel agent or to a broker, tour operator who arranges for the provision of transportation by the carrier to a third party, so long as the commission or referral fee does not exceed 10% of the applicable rate or charge specified in this tariff.

14. CHILDREN-UNACCOMPANIED: No person under the age of 21 will be permitted to take part in service unless a parent/guardian, or other responsible adult over the age of 21 accompanies the minors. Minors over 15 will be permitted to take part in service (without adult supervision), if they can provide the Parent Consent Form signed by the parent or legal guardian. We define an adult as any person who is 21 years of age, or older who is responsible for the care and supervision of the child during the charter service.

- 1. Cellular Phones: \$2.00 per minute.
- 2. Non-Equipment related rate for beverages and/or amenities (i.e. beverages, flowers, balloons, gifts, and etc.): \$30.00-per charter order plus cost of the items requested.
- C**3. Parking and airport passenger charges: A fee of \$6.00 per vehicle will apply to all charter services where the carrier is required to pay an airport parking fee to the Clark County Department of Aviation.
- 4. Airport Meet and Greet Service: We do not charge a Meet and Greet Fee for the Driver to meet the party in baggage claim.
- 5. Airport Vehicle Search Fee: A fee of \$3.00 per vehicle per security check when applicable will apply to all charter services where the carrier is required to pay an airport vehicle search fee to the Clark County Department of Aviation.
- 6. Rate is exclusive of rates for accompanying staff (Interpreter services, VIP hosts, or concierge services)
- 7A. Special Events are defined as High school proms, high school homecomings, NASCAR, NFR (National Finals Rodeo), and all events forecasted by the Las Vegas Convention and Visitors Authority with an estimated visitor count of 60,000 people or more at time of booking.
- 7B. Federal holidays are all holidays recognized by the United States government.
- I**8. Charters operating outside of Clark County will be charged an additional \$50 per charter hour for each hour outside of Clark County for Added mileage, fuel and maintenance expenses.
- 9. Corporate Accounts: customers who have usage of (40) forty hours or more a month for the current month- Rates will be based on **.
- 10. Any toll charges, parking or other trip fees, and park entrance fees are the responsibility of the customer.
- C**11. Any long distance trip over 6-hours driving one way, requires an overnight stay at turning point, making the trip two days. A Per Diem of \$125.00 per night plus \$25.00 per hour waiting time will be charged in lieu of driver lodging and meal expenses.
- 12. Limousine Equipment Packages (i.e. TVs, DVD, I-pod Station, Smoke Machines, Laser Lights, etc.) will be at a cost of \$25.00 per hour per amenities package
- 13. Infant/Toddler Car seat rental fee: \$15 per car seat

FUEL SURCHARGE TABLE AND RULES

The following Fuel Surcharge Rules will apply to carriers who are authorized to provide charter service by limousine and who are authorized to charge and collect a fuel surcharge:

1. The price of regular and diesel fuel is an amount equal to the retail price per gallon of regular and diesel fuel effective for the 25th calendar day of the immediately preceding month determined according to the United States Department of Energy (DOE), Energy Information Administration (EIA) survey on Weekly Retail Gasoline and Diesel Prices, Regular Grade - West Coast (PADD 5) and Weekly Retail Gasoline and Diesel Prices, Diesel, All Types - West Coast (PADD 5). The prices may be obtained by calling the DOE, EIA at (202) 586-8800 or via the DOE, EIA website at www.eia.doe.gov, via the "Petroleum" link.
2. If the 25th day of the calendar month is a Federal holiday, the fuel price will be determined based on the stated DOE price available on the next subsequent business day.
3. The DOE fuel price obtained will then be indexed based on the matrix set forth below to determine the fuel surcharge. The fuel surcharge will apply for all charter limousine transportation beginning on the 1st day of the following month and will remain in effect through the last day of that calendar month.
4. The fuel surcharge will be added on an hourly basis utilizing the matrix set forth below. The resulting charge is in addition to all other applicable transportation charges.

When the DOE Fuel Price Per Gallon reported on the 25 th of the month is:	The Fuel Surcharge that becomes effective on the 1 st day of the following month is:

NOTE 1: The fuel surcharge that is applicable for a given month must be passed along to all customers.

3% TAX Pursuant to SECTION 51 of AB175

The following rules apply to carriers who provide passenger transportation, excluding airport transport service:

Pursuant to Nevada Legislative Senate Bill No. 376

Sec. 36. Section 51 of Assembly Bill No. 175 of this session is hereby amended to read as follows:

Sec. 51. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.

2. The provisions of subsection 1 do not apply to an airport transfer service.

3. (Intentionally omitted)

4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and places in this State. The term does not include charter services by bus, charter services by limousine, scenic tours or special services.

NOTE 1: The passenger transportation recovery charge must be passed along to all customers.

NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.
