RULES AND REGULATIONS

APPLICATION OF TARIFF – GENERAL

Fares and charges herein are for transportation of passengers and their baggage between points, which this carrier is authorized to serve under the terms of certificate of public convenience and necessity issued by the Nevada Transportation Authority, in the State of Nevada.

OBJECTIONABLE PERSONS NOT TAKEN AS PASSENGERS:

We, as carriers, reserve the right to refuse transportation to any person under the influence of intoxicants or drugs or incapable of taking care of himself, and when conduct is such or likely to be objectionable to other passengers as prospective passengers. This rule does not apply to persons who are ill or incapacitated and are accompanied by an attendant or nurse.

WAITING TIME:

In connection with the rate per hour waiting time, as shown on on page 2, the meter will be set on time and will register a charge of approximately forty-three (\$0.43) cents for each one (1) minute, for a total of \$26.00 per hour.

APPLICATION OF RATES AND CHARGES:

The rates and charges as herein set out shall be for the exclusive occupancy of a taxicab by a person or persons traveling as one single fare, and it shall constitute a violation of the commission's rules and regulations in the event any attempt is made by either the company or the driver, to solicit or collect more than one fare for any single trip.

3% TAX Pursuant to SECTION 51 of AB175

The following applies to carriers who provide passenger transportation by taxicab:

Pursuant to Nevada Legislative Senate Bill No. 376

Sec. 37. Section 52 of Assembly Bill No. 175 of this session is hereby amended to read as follows:

Sec. 52. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a certificate holder of a passenger to a taxicab willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each certificate holder the excise tax imposed by this subsection.

NOTE 1: The passenger transportation recovery charge must be passed along to all customers.

NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.
