Rule No. (5)	<p><b><u>APPLICATION OF TARIFF</u></b></p> <p>Rules, regulations, rates and charges named in this tariff apply to the transportation of passengers and their baggage in charter bus service between points and places in the State of Nevada as set forth by NAC 706.</p>
(10)	<p><b><u>COMPUTATION OF RATES AND CHARGES</u></b></p> <p>Rates and charges named in this tariff are applicable to live service.</p>
(15)	<p><b><u>BAGGAGE</u></b></p> <p>(a) Hand baggage not to exceed forty (40) pounds per adult passenger will be permitted.</p> <p>(b) No tools or articles with sharp edges will be carried unless securely and safely packaged.</p> <p>(c) No explosives, inflammables, or liquids which could contaminate or be harmful to passengers or equipment will be carried.</p>
(20)	<p><b><u>ANIMALS</u></b></p> <p>Dogs, cats, or other live animals will not be carried unless properly confined in an approved container. EXCEPTION: Seeing-Eye dogs in the performance of their duty guiding blind persons and Aurally Assistance dogs.</p>
(25)	<p><b><u>OBJECTIONABLE PERSONS</u></b></p> <p>Carrier reserves the right to refuse transportation to any person under the influence of intoxicants or drugs, or incapable of taking care of him/herself, or when conduct is likely to be objectionable to other passengers or prospective passengers. This rule does not apply to persons who are ill or incapacitated and are not accompanied by an attendant or nurse.</p>
(30)	<p><b><u>CARRIER'S LIABILITY</u></b></p> <p>Carrier will not be liable for loss or damage to baggage or the contents thereof unless occasioned by lack of reasonable care on its part, and then only for the loss of, or damage to, any single piece of baggage, including its contents up to \$250.</p>

(35)	<p><b><u>CLAIMS</u></b>  Claims for loss or damage to baggage must be filed in writing with the Carrier within seven (7) days after the loss or damage is discovered. Upon receipt of the claim, Carrier shall have fourteen (14) days in which to locate lost baggage before making settlement, or deliver to the shipper a written denial of the claim. A denial of a claim may be appealed by the shipper to the Authority.</p>
(40)	<p><b><u>TYPES OF VEHICLES</u></b>  Shall be an original manufactured bus with a passenger capacity greater than fifteen (15).</p>
(45)	<p><b><u>AIRPORT FEE</u></b>  All charter bus service originating at McCarran Airport will include an airport fee.</p>
(50)	<p><b><u>HOLIDAY / EVENT</u></b>  Charter rates will be increased by the following percentage(s) based on the number of events / holidays occurring within a seven (7) day period (Sunday – Saturday).  *This fee increase is not applicable to qualifying high-volume customers.</p> <p>*A 10% rate increase will be applied to charter service when a holiday/event occur in same week.  *A 20% rate increase will be applied to charter service when two holiday/event occur in the same week.  *A 25% rate increase will be applied to charter service when three holiday/event occur in the same week.  *A 30% rate increase will be applied to charter service when more than three holiday/event occur in the same week.</p>

**FUEL SURCHARGE TABLE AND RULES**

The following Fuel Surcharge Rules will apply to carriers who are authorized to provide charter service by bus and who are authorized to charge and collect a fuel surcharge:

1. The price of regular and diesel fuel is an amount equal to the retail price per gallon of regular and diesel fuel effective for the 25<sup>th</sup> calendar day of the immediately preceding month determined according to the United States Department of Energy (DOE), Energy Information Administration (EIA) survey on Weekly Retail Gasoline and Diesel Prices, Regular Grade – West coast (PADD 5) and Weekly Retail Gasoline and Diesel Prices, Diesel, All Types – West Coast (PADD 5). The prices may be obtained by calling the DOE, EIA at (702) 586-8800 or via the DOE, EIA web site at [www.eia.doe.gov](http://www.eia.doe.gov), via the "Petroleum" link.
2. If the 25<sup>th</sup> day of the calendar month is a Federal holiday, the price will be determined based on the stated DOE price available on the next subsequent business day.
3. The DOE fuel price obtained will then be indexed based on the matrix set forth below to determine the fuel surcharge. The fuel surcharge will apply for all charter limousine transportation beginning on the 1<sup>st</sup> day of the following month and will remain in effect through the last day of that calendar month.
4. The fuel surcharge will be added on an hourly basis utilizing the matrix set forth below. The resulting charge is in addition to all other applicable transportation charges.

**NOTE 1:** The fuel surcharge, if applicable for a given month, must be passed along to all customers.

**NOTE 2:** The fuel surcharge must be shown separately from the charter revenue on carrier transportation documents for the purpose of identifying the amount as special fuel-related revenue.

**3% TAX Pursuant to SECTION 51 of AB175**

The following rules apply to carriers who provide passenger transportation, excluding airport transport service:

**Pursuant to Nevada Legislative Senate Bill No. 376**

**Sec. 36. Section 51 of Assembly Bill No. 175 of this session is hereby amended to read as follows:**

**Sec. 51. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.**

**2. The provisions of subsection 1 do not apply to an airport transfer service.**

**3. (Intentionally omitted)**

**4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and places in this State. The term does not include charter services by bus, charter services by limousine, scenic tours or special services.**

**NOTE 1: The passenger transportation recovery charge must be passed along to all customers.**

**NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.**
