Rules and Regulations for Drivers

1. Drivers must be twenty-one years of age or older.
2. Drivers must have Class C-2 Nevada Drivers Licenses.
3. Drivers must have excellent health and eyesight correctible to 20/20. Physical examination by a medical doctor is a prerequisite to commencement of employment, and a physical examination is required on each anniversary of hiring.
4. Drivers must be of high moral character. Ex-felons and persons convicted of crimes of moral turpitude shall not be hired. Sheriff's cards are required, and prospective drivers may be subjected to reasonable background checks to ensure a conclusion of high moral character.
5. Formal classroom training such as is offered to public school bus drivers, or comparable, is preferred. At such time as that ten-hour course becomes available to private transportation companies, it will be a prerequisite to commencement of employment.
6. Drivers shall not smoke on the bus.
7. Drinking alcoholic beverages while on the job shall constitute grounds for immediate dismissal. One conviction for DUI may be grounds for dismissal wherever incurred, and a second such conviction shall cause immediate termination of employment.
8. Drivers shall wear uniforms supplied by he applicant.
9. Drivers shall daily inspect the complete interior and exterior of their busses for any safety defects, such as burned out signal bulbs, condition of brakes, seating and general conditions. Drivers shall clean their busses daily.

Rules and Regulations

1. Payment shall be in advance on the first school day of each week by the child or parent giving the weekly payment to the driver.
2. Misbehaving children shall be given three chances to correct their behavior and conduct themselves in a safe and acceptable manner. Parents of problem children shall be advised of the problem, and if the matter is not rectified, the child shall be refused future service. Instances of gross or dangerous conduct may be grounds for immediate denial and cessation of service to a child.
