RULES AND REGULATIONS

5. APPLICATION OF TARIFF:

Fares, rates, rules and regulations named herein apply to the transportation of passengers and their baggage by LVL, LLC DBA LAS VEGAS LIMOUSINES, STARDUST TRANSPORTATION ("Carrier"), in accordance with the Certificate of Public Convenience and Necessity issued by the Nevada Transportation Authority.

6. PASSENGER AGENT:

Carrier may elect to appoint as its agent any organization, firm, corporation, motel, hotel, or legal gaming operation, who individually or collectively, desire to obtain passenger livery service between one or more common points for the collection of all applicable charges and remittance thereof direct to carrier without individual passenger fare collection by the Carrier.

8. DAMAGE TO VEHICLES:

- (A) Each vehicle dispatched for a charter will be in good condition upon arrival. Any damage to the vehicle which is caused by the charter customer(s) will be charged by the Carrier to the customer(s).
- (B) A special cleaning fee (actual Cost) will be assessed to the passenger(s) for damages caused by intentional acts of negligence, and damages caused by pets or animals.
- (C) Sickness fee \$250.00; cigarette burns fee \$350.00; smoking fine \$100.00; broken or missing decanters fee \$50.00; broken or missing glasses fee \$10.00 per glass.

RULES AND REGULATIONS

11. OBJECTIONABLE PERSONS:

The driver of the limousine shall have the absolute right to refuse to board anyone under the influence of alcohol or drugs or otherwise incapable of taking care of himself or herself, or who would, in the opinion of the driver, otherwise be obnoxious or dangerous to fellow passengers. The driver shall also have the right to refuse to board and may eject any passenger for becoming conduct. This Rule does not apply to persons who are ill and are accompanied by an attendant or nurse.

20. BAGGAGE:

- (A) Passengers will not be permitted to board the limousine with firearms, (unless the firearm is disassembled, or unloaded in a carrying case); explosives; inflammables; or any other article or substance which, in the opinion of the driver, could be harmful or obnoxious to fellow passengers.
- (B) Passengers boarding the limousine with sharp pointed tools or instruments will have such tools or instruments wrapped securely, and any pointed ends protected to prevent injury to other passengers.

Luggage is not to exceed two (2) suitcases or similar articles, and not to exceed fifty (50) pounds per passenger will be permitted per adult fare. Additional luggage may be carried on a space available basis for a flat fee of \$20.00.

25. ANIMALS OR PETS:

Animals or pets will not be allowed to board with the passengers unless properly confined in a suitable container so as to be loaded in the passenger or baggage compartment of the limousine. This Rule shall not apply to guide or "medical assisting animals" for blind and disabled customers, in the performance of their duty.

30. LIABILITY LIMITATIONS AND CLAIMS PROCEDURES:

- (A) Carrier will not be responsible for, or liable to passengers, for personal articles lost by or stolen from passengers.
- (B) Carrier will not be liable for loss or damage to baggage, or the contents thereof, unless occasioned by lack of due care on the part of the Carrier or its agents, and in the event, will only be liable for the reasonable value thereof, not to exceed Two Hundred and Fifty Dollars (\$250.00) for any single piece of baggage, including the contents thereof.
- (C) A claim by a shipper or consignor against a common or contract carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the lost or damage is discovered. Within 14 days after receipt of the claim, the carrier shall; (i) Compensate the shipper or consignor; or (ii) Deliver to the shipper or consignor a written denial of the claim. A denial of a claim may be appealed by the shipper or consignor to the Authority.

35. COMPUTATION OF RATES AND CHARGES:

Hourly rates and charges named in this tariff are applicable to waiting time, deadhead and live service.

40. CANCELLATION:

Notice of cancellation by the patron(s), to be without charge, must be given to Carrier no less than twenty-four (24) hours prior to the departure time originally agreed. If notice of cancellation by the patron(s) is not timely given, a charge equal to the minimum charge for the service originally requested will be payable.

45. DEPARTURE:

The departure of a limousine in airport transfer service from any airport may be delayed, at the discretion of Carrier, until a minimum of four fare paying passengers have boarded, in each instance. In no instance shall departure be delayed more than 15 minutes after the boarding of the first passenger.

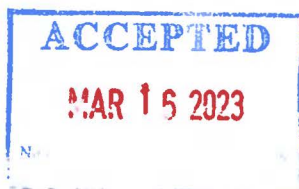

FUEL SURCHARGE TABLE AND RULES

The following Fuel Surcharge Rules will apply to all charter service by limousine and by bus, as described below:

1. The price of regular and diesel fuel is an amount equal to the retail price per gallon of regular and diesel fuel effective for the 25th calendar day of the immediately preceding month determined according to the United States Department of Energy (DOE), Energy Information Administrative (EIA) survey on Weekly Retail Gasoline and Diesel Prices, Regular Grade - West Coast (PADD 5) and Weekly Retail Gasoline and Diesel Prices, Diesel, All Types - West Coast (PADD 5). The prices may be obtained by calling the DOE, EIA at (202) 586-8800 or via the DOE, EIA website at www.eia.doe.gov, via the "Petroleum" link.
2. If the 25th day of the calendar month is a Federal holiday, the fuel price will be determined based on the stated DOE price available on the next subsequent business day.
3. The DOE fuel price obtained will then be indexed based on the matrix set forth below to determine the fuel surcharge. The fuel surcharge will apply for all charter limousine transportation beginning on the 1st day of the month. The adjustment determined will apply for all transportation beginning on the 1st day of the following month and will remain in effect through the last day of that calendar month.
4. The surcharge will be added on an hourly basis utilizing the matrix set forth below. The resulting charge is in addition to all other applicable transportation charges.

EXCISE TAX AND RULES

The following rules apply to carriers who provide passenger transportation, excluding airport transport service:

Pursuant to Nevada Legislature Senate Bill No. 376

Sec. 36. Section 51 of Assembly Bill No. 175 of this session is hereby amended to read as follows:

1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an exercise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of credit or debit card and any other amount that part of the fare. The Department of Taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.
2. The provisions of subsection 1 do not apply to an airport transfer service
3. (Intentionally omitted)
4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and places in this state. The term does not include charter services by bus, charter services by limousines, scenic tours or special services.

NOTE 1: The passenger transportation recovery charge must be passed along to all customers.

NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.

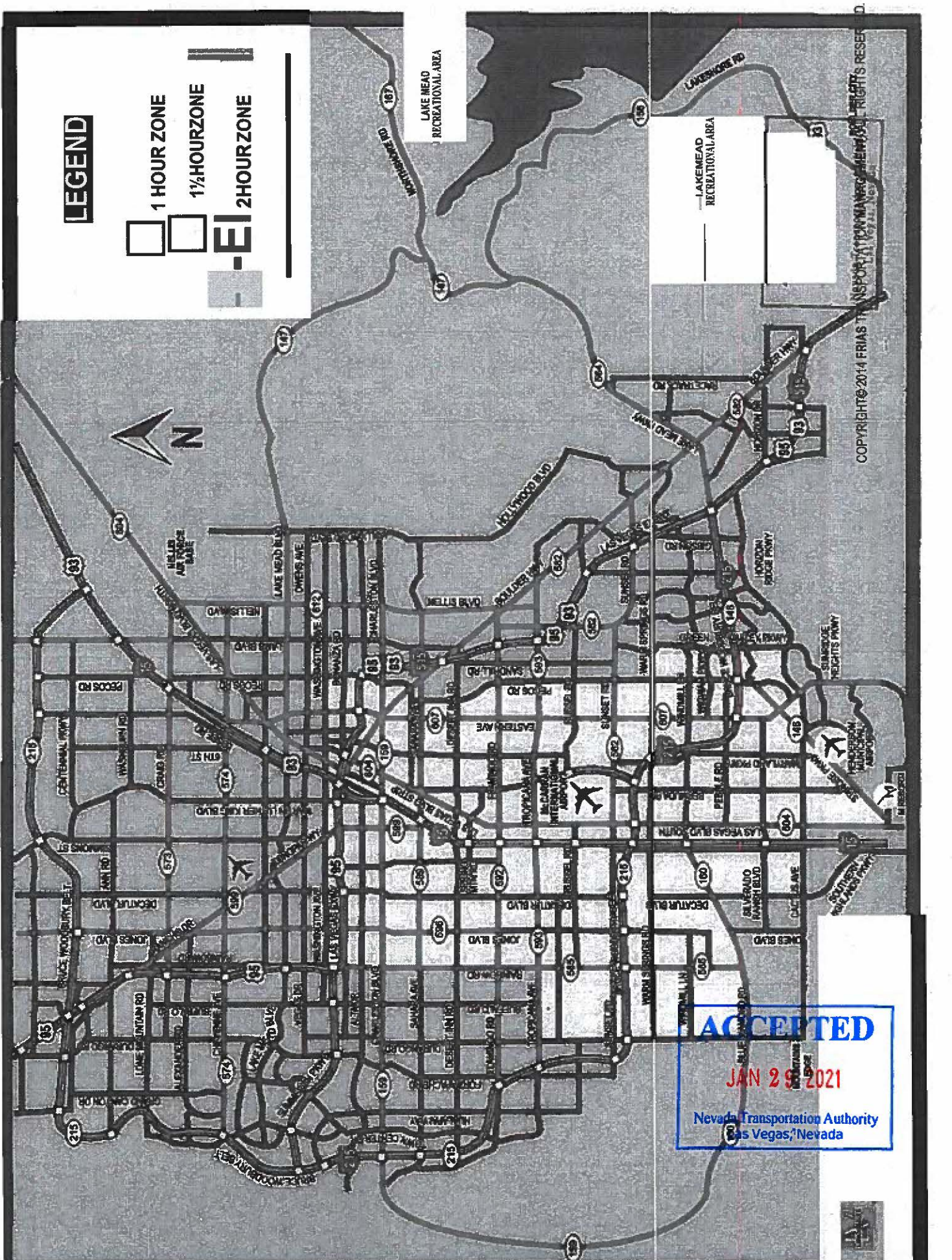
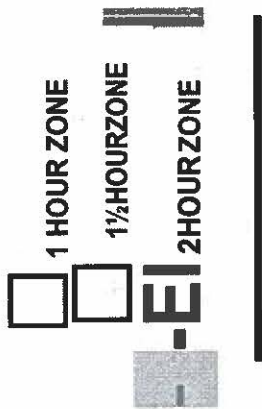
