RULE NO. RULES AND REGULATIONS

1. Minimum Load Requirement and Computation of Rate

For its scenic tour, carrier requires a load comparable to ten (10) fares in order to operate a tour. Carrier will operate with fewer passengers provided that the participants pay the minimum load rate.

2. Acceptance of Children

All ages welcome, Family friendly. Minors under the age of 18 are permitted as long as they are accompanied by an adult. No Alcohol can be consumed with persons under the age of 21 on board.

3. Right To Service

Carrier will not refuse service because of a person's race, creed, color, sex, or national origin.

4. Objectionable Persons

Carrier reserves the right to refuse transportation to any person who appears to be under the influence of intoxicants or drugs or who is incapable of taking care of himself or herself or whose conduct is likely to disrupt the safety or enjoyment of other passengers.

5. Carrier's Liability and Claims Procedures

A. Carrier will not be responsible for, or liable to passengers, for personal articles lost by or stolen from passengers.

B. A claim by a shipper or consignor against a common or contract motor carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered. Within 14 days after receipt of the claim, the carrier shall; (i) Compensate the shipper or consignor; or (ii) Deliver to the shipper or consignor a written denial of the claim. A denial of a claim may be appealed by the shipper or consignor to the Authority.

6. Cancellation

A. For Safety Reasons: Carrier reserves the right to cancel all or part of a tour due to inclement weather or other unforeseen circumstances that might adversely affect the health or safety of either passengers or the driver.

B. For Lack Of Participation: Carrier reserves the right to cancel a tour when it's minimum is not met.

C. or Unforeseen Circumstances: Carrier reserves the right to cancel a tour due to unforeseen circumstances (e.g., mechanical issues). Passengers will be notified and be given the choice of rescheduling the tour or receiving a full refund.

7. Payments and Refunds

Tour reservations, if reserved more than Seventy-Two (72) hours before the scheduled time slot, require a One Hundred (100) dollar deposit.

Tour reservations, if reserved less than Seventy-Two (72) hours before the scheduled time slot, require the full amount to be paid at the time of reservation.

Full payment will be processed Seventy Two (72) hours prior to the scheduled tour.

Tour cancellations, if received less than One (1) week prior to the scheduled tour, will receive no refund.

Tour cancellations, if received between One (1) week and Two (2) weeks prior to the scheduled tour, will receive a Fifty (50) dollar refund.

Tour cancellations, if received more than Two (2) weeks prior to the scheduled tour, will receive a full refund of One Hundred (100) dollars.

8. Methods of Payment

Carrier will accept MasterCard, Visa, American Express, and Discover. Cash or checks may be accepted at the discretion of the tour operator.

3% TAX Pursuant to SECTION 51 of AB175

The following rules apply to carriers who provide passenger transportation, excluding airport transport service:

Pursuant to Nevada Legislative Senate Bill No. 376

Sec. 36. Section 51 of Assembly Bill No. 175 of this session is hereby amended to read as follows:

Sec. 51. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.

2. The provisions of subsection 1 do not apply to an airport transfer service.

3. (Intentionally omitted)

4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and places in this State. The term does not include charter services by bus, charter services by limousine, scenic tours or special services.

NOTE 1: The passenger transportation recovery charge must be passed along to all customers.

NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.
