5	<p><u>APPLICATION OF TARIFF</u></p> <p>Rules, regulations, rates and charges named in this tariff apply to the transportation of:</p> <p>Passengers and their baggage in charter services and special services between points and places in the State of Nevada.</p> <p>Passengers and their baggage in airport transfer service between airports and between such airports and points and places in Clark County, Nevada.</p> <p>Passengers in scenic tour services within Clark and Nye Counties, Nevada on the one hand and points and places in the State of Nevada on the other hand.</p>
10	<p><u>BAGGAGE</u></p> <p>(a) Hand baggage not to exceed forty pounds (40) pounds per adult passenger will be carried free.</p> <p>(b) No tools or articles with sharp edges will be carried unless securely and safely packaged.</p> <p>(c) No explosives, flammables, or liquids that could contaminate or be harmful to passengers or equipment will be carried.</p>
15	<p><u>ANIMALS</u></p> <p>Dogs, cats, or other live animals will not be carried unless properly confined in an approved carrier. EXCEPTION: Seeing-eye dogs in the performance of their duty guiding blind persons.</p>
20	<p><u>APPLICATION OF RATES AND CHARGES</u></p> <p>Rates and charges named in the tariff are applicable to waiting time, deadhead and live service.</p>
25	<p><u>OBJECTIONABLE PERSONS</u></p> <p>The carrier/driver shall have the absolute right to refuse to board any perspective passenger under the influence of alcohol or drugs or otherwise appear incapable of taking care of him or herself. The driver shall also have the right to eject any passenger for unbecoming conduct. EXCEPTION: Incapacitated or ill persons accompanied by a nurse or guardian. EXCEPTION: Incapacitated or ill persons accompanied by a nurse or guardian.</p>
30	<p><u>CARRIER'S LIABILITY</u></p> <p>Carriers will not be liable for loss or damage to the contents thereof unless occasioned by lack of reasonable care on its part, and then only for the reasonable value thereof, subject to a maximum liability of \$250.00 for the loss of, or damage to, any single piece of baggage, including its contents.</p> <p><u>CLAIMS</u> for loss or damage to baggage must be submitted in writing to the carrier within seven (7) days after the loss or damage is discovered. Within fourteen (14) days after receipt of the claim, the carrier shall: compensate the claimant; or deliver to the claimant a written denial of the claim. A denial of the claim may be appealed by the claimant to the Nevada Transportation Authority.</p>

35	<p><u>CANCELLATION POLICY</u> For charter transportation that has been ordered more than 48 hours in advance, a cancellation charge equal to the minimum charge for the service requested will apply unless the customer provided the carrier with notice of the cancellation at least forty-eight (48) hours prior to scheduled start time.</p>
40	<p><u>VEHICLE DAMAGE AND CLEAN UP FEE</u> The customer will be charged the actual cost: (1) to repair damage to the vehicle caused by the passenger's intentional acts or negligence; or (2) where special cleaning beyond the carrier's normal procedures is required because of the passenger's intentional acts or negligence. Itinerary and points of origin and destination shall be within the certified area and further defined pursuant to N.A.C. 706.239.

Fares are per person, one-way in either direction, unless otherwise noted. Special Services shall be provided for a minimum number of eight (8) persons per special services contract.

**FUEL SURCHARGE**

The following Fuel Surcharge Rules will apply to carriers who are authorized to provide charter service by limousine and who are authorized to charge and collect a fuel surcharge:

1. The price of regular and diesel fuel is an amount equal to the retail price per gallon of regular and diesel fuel effective for the 25th calendar day of the immediately preceding month determined according to the United States Department of Energy (DOE), Energy Information Administration (EIA) survey on Weekly Retail Gasoline and Diesel Prices, Regular Grade – West Coast (PADD 5) and Weekly Retail Gasoline and Diesel Prices, Diesel, All Types - West Coast (PADD 5). The prices may be obtained by calling the DOE, EIA at (202) 586-8800 or via the DOE, EIA website at www.eia.doe.gov, via the "Petroleum" link.
2. If the 25th day of the calendar month is a Federal holiday, the fuel price will be determined based on the stated DOE price available on the next subsequent business day.
3. The DOE fuel price obtained will then be indexed based on the matrix set forth below to determine the fuel surcharge. The fuel surcharge will apply for all charter limousine transportation beginning on the 1<sup>st</sup> day of the following month and will remain in effect through the last day of that calendar month.
4. The fuel surcharge will be added on an hourly basis utilizing the matrix set forth below. The resulting charge is in addition to all other applicable transportation charges.

When the DOE Fuel Price Per Gallon Reported on the 25 <sup>th</sup> of the month is:	The Fuel Surcharge that becomes effective on the 1 <sup>st</sup> day of the following month is:

NOTE 1: The fuel surcharge that is applicable for a given month must be passed along to all customers.

NOTE 2: The fuel surcharge must be shown separately from the charter revenue on carrier transportation documents for the purpose of identifying the amount as special fuel-related revenue.

**3% TAX Pursuant to SECTION 51 of AB175**

The following rules apply to carriers who provide passenger transportation, excluding airport transport service:

**Pursuant to Nevada Legislative Senate Bill No. 376**

**Sec. 36. Section 51 of Assembly Bill No. 175 of this session is hereby amended to read as follows:**

Sec. 51. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.

2. The provisions of subsection 1 do not apply to an airport transfer service.

3. (Intentionally omitted)

4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and places in this State. The term does not include charter services by bus, charter services by limousine, scenic tours or special services.

NOTE 1: The passenger transportation recovery charge must be passed along to all customers.

NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.
