CHARTER BUSES SERVICE TARIFF**RULES AND REGULATIONS****1. CHARTER & ON-CALL SERVICES~ COMPUTATION OF RATES AND CHARGES:**

a. The charges shown below are for Charter, and/or On-Call, and/or Kelly Services, and cover continuous transportation, as well as, the time the vehicle is rented and reserved for passenger use, preventing use for other clients' transportation.

b. Rates and charges in this tariff are applicable to waiting time, and live services, and apply from the time the vehicle is dispatched from its base at 6442 Windy Road until passenger drop-off and return back to base with or without a passenger.

2. BAGGAGE: (a) Carrier will not be liable for loss or damage for contents thereof unless occasioned by lack of responsible care on its part and only in accordance with Rule 5 herein, (b) Articles with sharp edges, oversized baggage, or that which might otherwise damage the vehicles will not be carried unless securely and safely packaged. (c) Explosives, inflammables, or harmful liquids will not be transported. (d) Excess baggage other than hand baggage may be carried in an additional vehicle to be supplied by the Carrier at the rates and charges listed on Page 6, herein.

3. CANCELLATION: (a) **FEDERAL HOLIDAYS & SPECIAL EVENTS:** LGT requires a 7-day cancellation policy for all Federal Holidays & Special Events (defined on Page 7). For Federal Holidays & Special Events, the carrier will charge a 50%, non-refundable deposit on all transportation reservations. The cancellation fee shall be the entire deposit, unless request is cancelled more than 7 days from departure destination. All other cancellations require a notice of cancellation not less than twenty-four (24) hours prior to the departure time originally agreed upon. If notice of cancellation is not timely given (24 hours or more), a charge equal to the minimum charge for the service originally requested will be charged by the carrier.

4. LOST OR STOLEN ARTICLES: LGT is not responsible for lost or stolen articles that were left on, in, or around our vehicles. It is the parties' responsibility to monitor all of their belongings.

5. CARRIER'S LIABILITY, LIMITATIONS, AND CLAIM PROCEDURE: NAC 706.333 Claims for lost or damaged freight or baggage. (NRS 706.171)

1. A claim by a shipper or consignor against a common or contract motor carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered.

2. Within 14 days after receipt of the claim, the carrier shall:

(a) Compensate the shipper or consignor; or

(b) Deliver to the shipper or consignor a written denial of the claim.

3. A denial of a claim may be appealed by the shipper or consignor to the Authority. (Added to NAC by Pub. Service Comm'n, eff. 9-1-87; A by Transportation Serv. Auth. by R071-98,10-28-98)

6. DAMAGE TO VEHICLES: Each vehicle dispatched for a charter will be in good condition upon arrival. Any damage to the vehicle which is caused by the charter customer(s) will be charged by the Carrier to the customer(s) per item:

Damage, Vomit, & Special Cleaning	\$500
Cigarette Burns inside Limousine	\$500
Broken or missing glassware (champagne or Rocks glass)	\$5
Broken Window Shade	\$175
Flat Screen T.V.	\$500
Large Plasma Screen	\$2,500
Limousine Window	\$500
Stereo Equipment	\$2,500

7. CONTINUOUS CHARTER PROVISION: When a customer requests transportation requiring to be dropped off and then picked up again within 90 minutes of the drop off time, the trip will be considered as one continuous charter and the customer will be charged for the interim waiting time.

8. TYPES OF VEHICLES: (NAC 706.080) (Including the driver)

A) 16-32 Passenger Van or Shuttle Bus B) 16-30 Passenger Ford F650 C) 21-25 Passenger Limo Coach D) 26-30 Passenger Limo Coach E) 31-35 Passenger Limo Coach F) 36-60 Passenger Limo Coach G) 33-48 Passenger Shuttle Bus H) 49-57 Passenger Coach

9. REFUSAL TO CARRY PERSONS OR PASSENGERS: The driver of the transit vehicle shall have the right to refuse to carry any person or require any passenger to leave the vehicle if the person or passenger is intoxicated, unruly, is believed to be under the influence of narcotics, is believed to present a danger to the health or safety of the driver, or if verbal threats of any kind are made toward any staff member.

If a passenger vomits or spills liquids inside the car or defaces the vehicle, the customer is required to pay a \$500.00 cleanup fee.

10. ANIMALS: Animals, other than "Seeing Eye Dogs" and other dogs assisting handicapped customers, will not be carried unless properly confined.

11. LIABILITY: The carrier will not be liable for delays caused by an Act of God, public enemies, terrorism, authority of law, quarantine, perils of navigation, riots, strikes, traffic delays, and hazards or dangers incident to a state of war, accidents, breakdowns, bad road conditions, storms, and other conditions beyond its control, and does not guarantee arrival or departure from any point at a specified time. The Carrier will endeavor to maintain the schedule in the charter order but the same is not guaranteed. If any of the above actions occur and make it, in the sole opinion of the Carrier, inadvisable to operate a vehicle either from the place of origin or any point en route, the Carrier shall not be liable therefore, or be caused to be held for damages for any reason whatsoever.

12: ON BOARD LAVATORY: There will be a base service charge of \$250, plus \$75 per hour for the use of the bus lavatory and the removal of biowaste/cleaning.

12. COMMISSION OR REFERRAL FEE: Carrier may pay a commission or referral fee to a travel agent or to a broker who arranges for the provision of transportation by the carrier to a third party, so long as the commission or referral fee does not exceed 10% of the applicable rate or charge specified in this tariff.

13. CHILDREN-UNACCOMPANIED: No person under the age of 21 will be permitted to take part in service unless a parent/guardian, or other responsible adult over the age of 21 accompanies the minors. Minors over 15 will be permitted to take part in service (without adult supervision), if they can provide the Parent Consent Form signed by the parent or legal guardian. We define an adult as any person who is 21 years of age, or older who is responsible for the care and supervision of the child during the charter service.

14. PASSENGER AGENT: Carrier may select to appoint as its agent any organization, firm, corporation, motel, hotel, or legal gaming operation, who individually or collectively, desire to obtain passenger transportation service between one or more common points for the collection of all applicable charges and remittance thereof directly to carrier without individual passenger fare collection by the carrier.

Each vehicle class has a minimum charge of one hour. After the first hour, each additional 1/4 hour will be charged. Rates classified as * & **, as well as vehicles classified under "ADDITIONAL VEHICLES" (Two Hour Minimum) do NOT have a 1/4 hour rate.

*Rate applies for customer without prior reservations

**Point to Point is a direct pick up and drop off. No wait time or extra stops

***Applies when customers pre-arrange transportation via telephone, internet, or fax and does NOT include amenities

****Applies when customers pre-arrange transportation via telephone, internet, or fax and INCLUDES amenities

*****Applies for all federal holidays & special events

Note 1: Fuel cost price adjustment (Surcharge) will apply (See enclosed as accepted by the Nevada Transportation Authority)

CHARTER BUSES SERVICES

1. Cellular Phones: \$2.00 per minute.
2. Non-Equipment related rate for items (i.e. beverages, flowers, balloons, gifts, and etc.): \$30.00 per charter order plus cost of the items requested.
3. Parking and airport passenger charges: A fee of \$10.00 per vehicle will apply to all charter services where the carrier is required to pay an airport parking fee to the Clark County Department of Aviation. An airport fee of \$25 will apply to vehicles that can hold more than 30 passengers.
4. Airport Meet and Greet Service: When a customer requests to have additional staff, other than a driver, to meet their group to direct and assist guests to their transportation, this is considered to be Meet and Greet Service in which we will charge a fee of \$35 per hour for each person that they request to have us staff for them. Rate is exclusive of rates for accompanying staff (Interpreter services, VIP hosts, or concierge services)
5. Airport Vehicle Search Fee: A fee of \$3.00 per vehicle per security check when applicable will apply to all charter services where the carrier is required to pay an airport vehicle search fee to the Clark County Department of Aviation.
6. Holidays and Special Events are defined as New Years Eve & Day, High school proms, high school homecomings, NASCAR, NFR (National Finals Rodeo), Electric Daisy Carnival, and all events forecasted by the Las Vegas Convention and Visitors Authority with an estimated visitor count of 60,000 people or more. *****
7. Out of Town Charters (Charters operating outside of Clark County will be charged an additional \$10 per charter hour for (added mileage, fuel, and maintenance expenses).
8. Corporate accounts: Usage to average 40 hours or more a month for the current and previous three months will receive 10% off with amenities base rate ****. This rate will be extended, as a courtesy, to other limousine operators. No corporate rates on vehicles classified under "ADDITIONAL VEHICLES".

10. Any long distance trip over 6-hours driving one way, requires an overnight stay at turning point, making the trip two days. A Per Diem of \$150 (per night) will be charged in lieu of driver lodging and meal expenses.
11. Infant/Toddler Car seat rental fee: \$15 per car seat.
12. Ammenities include lights, ice, glasses, television and HDMI (High-Definition Multimedia Interface) setup. ****

FUEL SURCHARGE**Fuel Cost Price Adjustment (Surcharge)**

The following Fuel-Related Cost Price Adjustment (Surcharge) will apply on passenger transportation charges, as described below:

- On the 25th day of each calendar month, the price per gallon of gasoline will be determined based on the price stated by the U.S. Department of Energy (DOE), Energy Information Administration's (EIA) survey on "Retail On-highway Gasoline Prices - West Coast Average". This price will be obtained by calling the DOE Fuel Hotline at (202) 586-6966 or via the DOE Internet website at www.eia.doe.gov
- If the 25th day of the calendar month is a Federal holiday, the price will be determined based on the stated DOE price available on the next subsequent business day.
- The DOE fuel price obtained will then be indexed based on the fuel price adjustment factor matrix set forth in this item to determine the Fuel Cost Price Adjustment that will become applicable on the 1st day of the following month and will remain in effect through the last day of that calendar month.
- The surcharge will be added on an hourly basis utilizing the matrix set forth below. The resulting charge is in addition to all other applicable transportation charges.
