**GOVERNING PUBLICATION**

This tariff is governed by Official Nevada Highway Map issued by Nevada Department of Transportation

**DEFINITIONS OF TERMS USED**

**Shuttle Bus:** a unit of motor passenger equipment assigned to the specific use of shuttle transportation and special service transportation  
**Passenger(s):** Individual persons traveling on the shuttle bus  
**Shuttle Service:** Transportation and incidental service furnished by shuttle carrier between authorized points of origin  
**Shuttle Schedule:** Times for shuttle pick up and drop off at designated locations  
**Rider ship:** Number of persons (individually) collectively traveling on each shuttle

**APPLICATION OF CHARGES**

Charges shown herein apply for "Shuttle Service" over paved and oil roads, over which the shuttle bus can operate safely and without undue wear to the equipment. Carrier will not travel over unpaved or gravel roads. Carrier reserves the right to choose routes other than the shortest route due to weather, road conditions, weight limitations, civil disorder, riots, floods or other acts of God.

**BAGGAGE**

Luggage not to exceed two pieces per fare ticket and not to exceed 50 pounds each piece. Only carry on luggage allowed in the interior of the shuttle bus.
