RULES AND REGULATIONS

APPLICATION OF TARIFF

1 Rules, rates and charges named herein are for the transportation of passengers and their baggage between points which this carrier is authorized to serve under the terms of the New Certificate of Public Convenience and Necessity issued by the Transportation Services Authority of Nevada.

ANIMALS

2 Dogs, cats or other live animals will not be carried unless properly confined in an approved container. Exception: Seeing-eye dogs in the performance of their duty guiding blind persons.

OBJECTIONABLE PERSONS

3 Carrier reserves the right to refuse transportation to any person under the influence of intoxicants or drugs, or incapable of taking care of himself or herself, or when conduct is likely to be objectionable. This rule does not apply to persons who are ill or incapacitated, and are accompanied by an attendant or nurse.

OTHER RIGHTS OF REFUSAL FOR TRANSPORT

4 Carrier reserves the right to refuse transportation to any person;
a) carrying sharp objects that may damage the interior of the vehicle or become a danger to the driver or other passengers,
b) or carrying a weapon.

RULES AND REGULATIONS

5 INFLAMMABLES
 No explosives, inflammables, or liquids which could contaminate or be harmful to the passengers or vehicles will be carried.

6 CARRIER'S LIABILITY
 Carrier will not be liable for loss of or damage to passengers' belongings unless occasioned by lack of reasonable care on its part, and then only for the value thereof, with a maximum liability of \$100.00 per single piece of luggage or proven value of items.

7 CLAIMS
 Claims for damage must be filed in writing with the carrier within ten (10) days after incident. Carrier shall have reasonable time to evaluate claim before making settlement, which will not be more than (14) days from date of receipt of notice of such loss.

8 ROUGH ROADS
 The carrier reserves the right to refuse a trip to an area where the condition of the road or absence thereof would cause damage to the vehicle.

9 WAITING TIME
 In connection with the rate per hour for waiting time, as shown on page 5, the meter will be set on time and will register a charge of \$.25 cents for each (33) seconds. Maximum charge per hour is \$ 27.25 dollars.

10 APPLICATION OF RATES AND CHARGES:
 The rates and charges as set out herein shall be for the exclusive occupancy of a taxicab by a person traveling as one single fare, and it shall constitute a violation of the Authority rules and regulations in the event any attempt is made either by the company or the driver, to solicit or collect more than one fare for any single trip.
