20	<p><u>APPLICATION OF TARIFF</u></p> <p>The rates and charges as herein set out shall be for the exclusive occupancy of a taxicab by a person or persons traveling as one single fare, and it shall constitute a violation of the Commission's rules and regulations in the event any attempt is made by either the company or the driver to solicit or collect more than fare for any single trip.</p>
25	<p><u>SENIOR DISCOUNT</u></p> <p>Pursuant to NRS 706.351, Senior Citizens, over 60 years of age, properly registered in the "Senior Ride" program will receive a rate discount upon presentation of authorized identification card.</p>
30	<p><u>AGREEMENT</u></p> <p>Customers who have established a credit account with Whittlesea Taxi will be entitled to a 10% discount, on all metered fares, if the customer completes more than 50 trips within 30 consecutive days.</p>

35	<p><u>3% PASSENGER TRANSPORTATION RECOVERY CHARGE AND RULES</u></p> <p>The following applies to carriers who provide passenger transportation by taxicab:</p> <p>Pursuant to Nevada Legislative Senate Bill 376 Sec. 37 Section 52 of Assembly Bill No. 175 of this session is hereby amended to read as follows:</p> <p>Sec.52. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a certificate holder of a passenger to a taxicab willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each certificate holder the excise tax imposed by this subsection.</p> <p>Note 1: The passenger transportation recovery charge must be passed along to all customers.</p> <p>Note 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.</p>
