RULES AND REGULATIONS

1. APPLICATION OF TARIFF

Rules, Regulations, Rates and Charges named in this tariff apply to the transportation of passengers and their baggage in Scenic Tour Service and Charter Service between points and places in Clark County, NV. Rates and charges provided in this tariff, for services as ordered, shall be prepaid or paid by established accounts within 30 days of service.

2. NON DISCRIMINATION

Carrier will not refuse service to anyone because of race, creed, sex or national origin.

3. MINIMUM LOAD REQUIREMENT AND COMPUTATION OF RATE

For Scenic Tour Service, carrier does not require a minimum load in order to operate a tour. Carrier charges a flat rate based on maximum passenger load for the vehicle, excluding the driver. For Charter Service, a minimum of 1 hour is required with billing at ½ hour increments.

4. ACCEPTANCE OF CHILDREN

Children under the age of 18 years must be accompanied by an adult. An adult is classified as an individual 18 years or older who is responsible for the child during the tour. Each child must occupy a seat with a separate seat belt. Carrier will not accept lap children for transportation.

Children who are less than 6 years of age and who weigh 60 pounds or less shall be secured in a child restraint seat which has been federally approved, is appropriate for the size and weight of the child and is installed within and attached safely and securely to the motor vehicle in accordance with the instructions for installation and attachment provided by the manufacturer of the child restraint seat; or in another manner that is approved by the NHTSA. (NRS 484B.157)

Carrier will require the accompanying adult to provide the appropriate child restraint seat.

5. OBJECTIONABLE PERSONS

Carrier reserves the right to refuse service to any person who appears to be under the influence of intoxicants or drugs, or who is incapable of taking care of him/her self or whose conduct is likely to disrupt the safety or enjoyment of other passengers, prospective participants, or driver.

6. SEAT BELTS

Carrier requires all passengers to wear seat belts when the vehicle is in motion or on a roadway. Carrier reserves the right to refuse service to any person who cannot or will not wear a seat belt.

7. CARRIER'S LIABILITY

Carrier will not be liable for loss of personal property or injury. Carrier will not be liable for delays caused by an act of God, public enemy, authority of law, quarantine, riots, strikes, force majeure, accidents, breakdowns, unnavigable conditions of the road, storms, and other conditions beyond its control. Carrier will endeavor to maintain the schedule submitted by its agent or employee; and, over routes indicated, but the same is not guaranteed.

In the event of any of the above conditions exist and, in the opinion of the Carrier, it is inadvisable to operate its equipment from the point of origin to any point in route. Carrier shall not be liable therefore, or be held in damages for any reason whatsoever.

8. CANCELLATION OF TRIPS AND REROUTING

Carrier reserves the right to cancel or reroute any given trip due to inclement weather or other unforeseen circumstances that might adversely affect the health or safety of either the participants or the driver.

9. TOUR MODIFICATIONS

Carrier reserves the right to alter or modify any tour at any time throughout the tour. If said tour is cancelled due to inclement weather, unsafe conditions, or any other unforeseen event which might adversely affect the health or safety of the participants or the driver, a full refund will be issued.

10. METHODS OF PAYMENT AND REFUNDS

- a. At the time reservation is made, a Visa, Mastercard, or Discover number is needed to guarantee the trip reservation. If participant would prefer, arrangements can be made to accept payment through Paypal as well.
- b. Deposit payment due at time of reservation. Credit card will be charged for a minimum of 50 percent of the total charge when used as a guarantee of payment. If Paypal is the payment method of choice, participant will be required to submit at least 50 percent of total charge. Deposit is nonrefundable unless the Carrier is the cause for cancellation. Credit card, Paypal or cash will be required for payment completion prior to start of the trip. No personal checks accepted.
- c. If passengers are paid in full; at least 48 hour cancellation is required for 50% refund.
- d. 10 minutes late constitutes a "NO SHOW" cancellation and no refund will be given.

11. ALCOHOLIC BEVERAGES AND SMOKING

The transportation and consumption of alcoholic beverages is strictly forbidden at any and all points throughout the trip. Smoking of any kind but not limited to cigarettes, cigars, medical marijuana, etc. will not be permitted in any of the carrier's vehicles.

12. ANIMALS

Animals, other than ADA (Americans with Disabilities ACT) Service Animals will not be carried unless properly confined. A special cleaning fee (actual cost) will be assessed to the passenger(s) for damages caused by pets or animals.

13. VEHICLE DEFINITIONS

1. Luxury Sedan is a vehicle herein described as a **1956 Pink Cadillac DeVille (fully refurbished and operational)** and includes most of the features provided by the manufacturer, with a passenger capacity of 5, plus the driver.
2. Luxury Imperial Sedan is a vehicle herein described as a **1955 Black Cadillac Fleetwood** and includes most of the features provided by the manufacturer, with a passenger capacity of 7, plus the driver.

14. BAGGAGE

- a) Hand baggage shall not exceed fifty (50) pounds per bag
- b) Each passenger will be allowed no more than one bag and one carry on size item
- c) Articles with sharp edges will not be carried unless safely and securely packaged
- d) Explosives, inflammables, or harmful liquids will be transported

15. LIABILITY

Powers, LLC (dba Best Elvis in Las Vegas) is not responsible for any lost property that is left in the vehicle.

In accordance with NAC706.333,

1. A claim by a shipper or consignor against a common or contract motor carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered.
2. Within 14 days after the receipt of the claim, the carrier shall:
 - a) Compensate the shipper or consignor; or
 - b) Deliver to the shipper or consignor a written denial of the claim.
3. A denial of a claim may be appealed by the shipper or consignor to the Authority.

16. EQUIPMENT SUBSTITUTIONS

When scheduled equipment is not available, due to breakdowns or the total number of passengers, Applicant may at their discretion substitute equipment.

17. DAMAGE AND SPECIAL CLEANING

Each time a vehicle is dispatched for a Charter or Scenic Tour Service, the vehicle will be in good condition upon arrival. Any damage to the vehicle which is caused by intentional acts or negligence of the passenger(s) will be charged by the carrier to the customer(s) as follows:

Per item minimum fees:

*If cost is greater, customer will be responsible for actual cost of damage caused.

Damages (interior, doors, scratches, dents)	\$ 100.00 minimum
Damages (vomit & special cleaning)	\$ 300.00 minimum
Cigarette Burns inside car	\$ 250.00 minimum
Seat tears and/or rips in the interior	\$ 500.00 minimum

Once back in the car we will drive past the hotel Elvis performed at during his residency in Las Vegas then travel down Wedding Chapel Row past all the Elvis themed chapels, then down the center of the Fremont Street Experience before returning you to your hotel.

B. ELVIS BLACK CADILLAC TOUR (2 hours).....\$630.00 (for up to 7 passengers)

CHARTER SERVICE BY LUXURY SEDAN RATES AND CHARGES

- 1. A. 1956 Pink Cadillac, Sedan DeVille (5 passengers + driver)
 - Minimum Charge – one hour \$ 59.00
 - Thereafter, billed in ½ hour increments of \$ 29.50 per ½ hour

- B. 1955 Black Cadillac, Fleetwood Imperial Sedan (7 passengers + driver)
 - Minimum Charge – one hour \$ 75.00
 - Thereafter, billed in ½ hour increments of \$ 37.50 per ½ hour

2. Driver gratuities are not included. Rates are exclusive of rates for accompanying staff and services (tour guide, performance services), toll charges, parking or other trip fees, park entrance fees or amenities.

- 3. Amenities will be at cost plus \$ 10.00 per amenity
 - a.) Amenities include, but are not limited to, flowers, gifts & food
 - b.) Amenities beverage package (Ice, Water, Cups, Napkins, Glassware) \$10.00 per package

Each reservation has a minimum charge of one hour. Charges begin when the vehicle is dispatched (i.e., 20 minutes prior to pick up for all hotels located in the Strip/Downtown area between Cactus Ave and Washington Ave. and between Maryland Parkway and Decatur Blvd.; 30 – 45 minutes prior to pick up at residential, businesses and hotels located away from the strip or downtown.) Charges end when the driver is expected to return from drop off. Charges will accrue in ½ hour increments and not until 7 minutes or more have elapsed into the succeeding ½ hour.

FUEL SURCHARGE TABLE AND RULES**

The following Fuel Surcharge Rules will apply to carriers who are authorized to provide charter service by limousine and who are authorized to charge and collect a fuel surcharge:

1. The price of regular and diesel fuel is an amount equal to the retail price per gallon of regular and diesel fuel effective for the 25th calendar day of the immediately preceding month determined according to the United States Department of Energy (DOE), Energy Information Administration (EIA) survey on Weekly Retail Gasoline and Diesel Prices, Regular Grade - West Coast (PADD 5) and Weekly Retail Gasoline and Diesel Prices, Diesel, All Types - West Coast (PADD 5). The prices may be obtained by calling the DOE, EIA at (202) 586-8800 or via the DOE, EIA website at www.eia.doe.gov, via the "Petroleum" link.
2. If the 25th day of the calendar month is a Federal holiday, the fuel price will be determined based on the stated DOE price available on the next subsequent business day.
3. The DOE fuel price obtained will then be indexed based on the matrix set forth below to determine the fuel surcharge. The fuel surcharge will apply for all charter limousine transportation beginning on the 1st day of the following month and will remain in effect through the last day of that calendar month.
4. The fuel surcharge will be added on an hourly basis utilizing the matrix set forth below. The resulting charge is in addition to all other applicable transportation charges.

When the DOE Fuel Price Per Gallon reported on the 25 th of the month is:	The Fuel Surcharge that becomes effective on the 1 st day of the following month is:
\$2.25 - \$2.74	\$2.00
\$2.75 - \$3.24	\$3.00
\$3.25 - \$3.74	\$4.00
\$3.75 - \$4.24	\$5.00
\$4.25 - \$4.74	\$6.00
\$4.75 - \$5.24	\$7.00
\$5.25 - \$5.74	\$8.00
\$5.75 - \$6.24	\$9.00
\$6.25 - \$6.74	\$10.00

NOTE 1: The fuel surcharge that is applicable for a given month must be passed along to all customers.

NOTE 2: The fuel surcharge must be shown separately from the charter revenue on carrier transportation documents for the purpose of identifying the amount as special fuel-related revenue.
