RULES AND REGULATIONS

1. **Minimum Load Requirements:**

A minimum of two adult fares must be paid to warrant a tour being offered. If less than two individuals request that tour be offered, that individual would be required to pay the full fare as though there were two individuals.

2. **Unaccompanied Children:**

No person under the age of 18 will be permitted to take part in any tour unless they are accompanied by a parent, guardian, or other responsible adult.

3. **Infants:**

No children will be allowed to sit in a parent's lap. Infants and other small children who require infant seats or child safety seats will be allowed on the provision that the parent or a responsible adult provide the seat and install said seat in the vehicle using the vehicles safety belts.

4. **Alcohol, recreational drugs:**

No alcoholic beverages or recreational drugs will be allowed on the tour.

5. **Non-Discrimination:**

The carrier will not refuse service to anyone because of race, creed, sex or national origin.

6. **Right to Refuse Service:**

The carrier reserves the right to refuse service to anyone who may appear to be under the influence of alcohol and/or drugs. They also reserve the right to refuse service to anyone who may display an inability to care for themselves or displays conduct which may disrupt the pleasure and safety of other passengers or employees.

7. **Seat Belts:**

All passengers will be required to wear fastened seat belts at any time when the vehicle is in motion or on a roadway. Carrier reserves the right to refuse service to anyone who cannot or will not wear a seat belt.

RULES AND REGULATIONS

8. Trip Cancellation or Rerouting:

The carrier reserves the right to cancel or reroute any given tour when weather conditions, health hazards or equipment malfunctions may affect the safety of passengers or employees.

9. Smoking in Vehicles:

Smoking will not be allowed in vehicles.

10. Discounts:

Once the minimum adult load requirements have been met, a \$20 price reduction will be allowed for children less than 12 years of age for the Reno-Virginia City trip and \$30 price reduction for the Reno-Genoa trip. A 10% discount will apply to all Seniors (age 65 and over).

11. Application of Rates:

Rates are listed on page 4. The time length of the trip will be determined from the last "pick up" to the time of "drop off".

12. Refunds:

Confirmed reservations canceled by the customer at least 7 days (168 hours) prior to the trip will be refunded 100% of their fare, if cancelled prior to 2 days (48 hours), a 75% refund would be allowed, and cancellation between 48 and 24 hours will be refunded 50%. Confirmed reservations canceled less than 24 hours will be charged in full. No refunds will be allowed if a customer is refused service because they appear to be under the influence of drugs or alcohol, or displays conduct that would disrupt the pleasure and safety of other passengers or driver. No refund will be given to anyone who is refused service because of refusal to wear a seatbelt. If **RubiTours** cancels a trip for any reason, bad weather or inadequate load requirements, a 100% refund will be issued. **RubiTours** reserves the right to cancel a trip. Note; the cancellation fees/ charges may be applied to future fares for the same parties traveling within 6 months of original booking.

13. Schedule:

Tours will be offered 7 days a week (except Thanksgiving Day, Good Friday, Christmas Eve, Christmas Day)

14. Length of Time Per Tour:

Drive from Reno to Virginia City will last approximately 60 minutes. Customers will be provided 2 hours for self-guided tours and shopping before being picked up and driven back to Reno. Drive time from Reno to Genoa will last approximately 90 minutes. Customers will be provided 2 hours for self-guided tours and shopping and picked up for the return trip to Reno.

15. Claims for lost or damaged freight or baggage:

(NAC 706.333 Claims for lost or damaged freight or baggage (NRS.706.171))

A claim by a shipper or consignor against a common or contract motor carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered.

Within 14 days after the receipt of the claim, the carrier shall:

- (a) Compensate the shipper or consignor, or
- (b) Deliver to the shipper or consignor a written denial of the claim.

A denial of a claim may be appealed by the shipper or consignor to the Authority.

Reno to Genoa (roundtrip)	\$125.00 adult \$95.00 children under 12 years of age

Rates are based on a minimum load of two adult passengers. Less passengers will be taken provided the minimum charge for two passengers is met. (Tariff rule #1) Children under 12 years of age will receive the discount of \$20.00 off the Reno to Virginia adult fare, and \$30.00 off the adult fare to Genoa. Children must be accompanied by a responsible adult (Tariff rule #2 and #10).
