**Rule No**

**5**      Application of Tariff

Rates in this Tariff cover ground transportation of passengers and their luggage, as provided in the Carrier's Operating Authority in charter operations in Clark, Lincoln, and NYE Counties, NV on one hand and point and places in Nevada on the other.

**10**     Rates and Charges

The length of charter will be determined from the pick up to the drop-off site. Rates and charges are applicable to waiting time, live service, and deadhead time, required travel of the vehicle without passenger between the point of passenger pickup or drop off, except that there will be no charge for deadhead time for transportation provided entirely within the area of the Las Vegas Valley.

Commission or Referral Fee- The carrier at its sole option may pay a commission or referral fee for transportation to a travel agent, tour broker, tour operator, or hotel/casino who arranges for the provision of transportation as long as it does not exceed 10% of the rate or charge specified in the tariff for the transportation.

**15**     Fare- Minimum

A minimum of one hour of fares must be paid to warrant all services being offered.

**20**     Children- Unaccompanied, and Fare

No person under the age of 18 will be permitted to take part in service, unless a parent, guardian or other responsible adult accompanies the minor, or signs a permission slip of the minor. We define as an adult any person who is 18 years of age or older who is responsible for the care and supervision of the child during the service. No child will have a reduced rate. No child will be allowed to sit in anyone's lap and children who require infant seats or safety seats will be allowed on the provision that a responsible adult provides such a seat and installs that seat in the vehicle securing it with the vehicle's safety belts.

**25**     Continuous Charter Provision

Where the customer requests transportation requiring the passengers to be dropped off and then picked up again at the same location within 60 minutes of the time of drop off for further service, the transportation will be considered as one continuous charter and the customer will be charged for the interim waiting time.

**Rule No**

30        Luggage  
Two piece of luggage per person, not to exceed seventy pounds each. Carrier will not be liable for loss or damage to luggage or contents thereof unless associated by lack of care of the carrier. Flammables or harmful liquids will not be transported.

35        Non discrimination  
Carrier will not refuse service to anyone because of race, creed, sex, or national origin.

40        Cancellation Fees  
Carrier reserves the right to charge a cancellation fee in the event that the request for services is cancelled with less than twenty-four hours' notice from the time the service is scheduled to commence. Cancellation with less than twenty-four hours' notice will be charged the full amount of the chartered services

45        Refunds  
To receive a full refund, cancellation of requested service must be received, at minimum, twenty-four hours prior to scheduled pick-up time.

50        Car Damage and Clean up Fee  
The customer will be charged the actual cost to repair damage to the vehicle caused by the passenger's intentional acts or negligence; or where special cleaning beyond the carrier's normal procedures are required because of the passenger's intentional acts or negligence.

55        Objectionable Persons  
The driver of the vehicle has the right to refuse transportation services to any person(s) who is/are considered intoxicated, unruly or believed to be under the influence of illegal drugs.

60        Seat Belts  
All passengers will be required to fasten the seat belts provided while the vehicle is in motion. Carrier reserves the right to refuse service to anyone who cannot, or will not, wear a seat belt.

**Rule No**

65        Smoking  
Smoking is prohibited in all carrier vehicles.

70        Liability  
The carrier will not be liable for the delays or cancellations caused by acts of God, public enemy, terrorism, authority of law, quarantine, riots, strikes, accidents, breakdowns, bad road conditions, storm and any or other conditions beyond its control. Carrier does not guarantee on-time arrival or departure from any point at a specified time; however, the carrier will strive to maintain the schedule submitted by the agent or employee, over indicated routes, but the same are not guaranteed. If any or the adverse conditions make it, in the opinion of the carrier, inadvisable to operate the equipment over any point en route, including departure and arrival points, the carrier will not be held responsible for damages for any reason(s) whatsoever.

75        Animals  
Animals will not be carried unless they are service dogs performing assistance for the handicapped.

80        Claims  
If loss or damage occurs, a claim for lost luggage or its contents must be reported and filed in writing with the carrier within seven (7) days of such incident. The carrier will investigate the matter and if said luggage is not located, a claim procedure will begin per NAC 706.333 within 14 days after receipt of claim, the carrier will either compensate for the claim, or deliver a written denial of the claim. A denial of a claim may be appealed by the shipper or cosigner to the Nevada Transportation Authority.

85        Passenger Agent(s)  
Carrier may appoint as its agent any legal organization, firm, corporation, hotel, motel, who individually, or collectively requires transportation services between one or more common points named in the tariff. Passenger Agent(s) may collect applicable charges and remit them to carrier.

6. Counts Kustoms Party Mini Coach with a maximum seating capacity of 15 (including driver)
  - Minimum charge, one hour \$125

7. Cellular telephone charges will be at cost plus \$2.00 per call
8. Amenities will be at cost plus 10% of total cost  
 Amenities will include flowers and gifts, but is not meant to be all inclusive

Note 2: Airport vehicle Search Fee: A fee of \$2.00 per vehicle per security check will apply to all charter service where the carrier is required to pay an airport vehicle search fee to the Clark County Dept. of Aviation

Note 3: Airport Parking (AVI) Toll Fee: A fee of \$5.00 per vehicle will apply to all charter service where the carrier is required to pay an airport parking fee to Clark County Dept. of Aviation

Note 4: Any customer who uses 40 hours or more of service in any calendar month and who submits payment in full by the fifteenth of the following month will receive a 10% discount off of their bill.

**FUEL SURCHARGE TABLE AND RULES**

The following Fuel Surcharge Rules will apply to carriers who are authorized to provide charter service by limousine and who are authorized to charge and collect a fuel surcharge:

1. The price of regular and diesel fuel is an amount equal to the retail price per gallon of regular and diesel fuel effective for the 25<sup>th</sup> calendar day of the immediately preceding month determined according to the United States Department of Energy (DOE), Energy Information Administration (EIA) survey on Weekly Retail Gasoline and Diesel Prices, Regular Grade- West Coast (PADD 5) and Weekly Retail Gasoline and Diesel Prices, Diesel, All Types- West Coast (PADD 5). The prices may be obtained by calling the DOE, EIA at (202) 586-8800 or via the DOE, EIA website at [www.eia.doe.gov](http://www.eia.doe.gov), via the "Petroleum" link.
2. If the 25<sup>th</sup> day of the calendar month is a Federal holiday, the fuel price will be determined based on the stated DOE price available on the next subsequent business day.
3. The DOE fuel price obtained will then be indexed based on the matrix set forth below to determine the fuel surcharge. The fuel surcharge will apply for all charter limousine transportation beginning on the 1<sup>st</sup> day of the following month and will remain in effect through the last day of that calendar month.
4. The fuel surcharge will be added on an hourly basis utilizing the matrix set forth below. The resulting charge is in addition to all other applicable transportation charges.

When the DOE Fuel Price Per Gallon reported on the 25 <sup>th</sup> of the month is:	The Fuel Surcharge that becomes effective on the 1 <sup>st</sup> day of the following month is:

NOTE 1: The fuel surcharge that is applicable for a given month must be passed along to all customers.

NOTE 2: The fuel surcharge must be shown separately from the charter revenue on carrier transportation documents for the purpose of identifying the amount as special fuel-related revenue.

Note 3: Rates for e-hailing are based solely on the rate set forth in this Tariff. The minimum hourly charge begins upon confirmation through the e-hail application that the patron's service request has been accepted, and hourly charges end when the passenger arrives at his/her destination and disembarks from the vehicle. Once service has been "accepted", patron shall be charged a one-hour minimum charge if patron is not at the designated pick-up location within ten (10) minutes of the stated arrival time ("No Show").

3% TAX Pursuant to Section 51 of AB175

The following rules apply to carriers who provide passenger transportation, excluding airport transport service:

**Pursuant to Nevada Legislative Senate Bill No. 376**

**Sec. 36. Section 51 of Assembly Bill No. 175** of this section is hereby amended to read as follows:

Sec. 51. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.

- 2. The provisions of subsection 1 do not apply to an airport transfer service.
- 3. (Intentionally omitted)
- 4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and places in this State. The term does not include charter services by bus, charter services by limousine, scenic tours or special services.

Note 1: The passenger transportation recovery charge must be passed along to all customers.

Note 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.
