RULSE AND REGULATIONS

LIABILITY

Sin City Luxury Charters is not responsible for any customers lost belongings or property that a customer leaves on the bus.

NAC 706.333 Claims for lost or damaged freight or baggage. (NRS 706.171)

1. A claim by a shipper or consignor against a common or contract motor carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered.
2. Within 14 days after receipt of the claim, the carrier shall:
 - (a) Compensate the shipper or consignor; or
 - (b) Deliver to the shipper or consignor a written denial of the claim.
3. A denial of a claim may be appealed by the shipper or consignor to the Authority.

OBJECTIONABLE PERSONS

The driver of the transit vehicle has the right to refuse transportation and/or ask any passenger to leave the vehicle if the person is under the influence of drugs, overly intoxicated, unruly, or proves to be a danger to others without issuing any refund.

SMOKING

Smoking will not be permitted on Sin City Luxury Charter's double decker bus.

RULES AND REGULATIONS

CANCELLATIONS/REFUND

Cancellations must be done by the booking party within 24 hours of when the reservation is first made and reservations must be made at least 4 days prior to the scheduled transportation date in order to receive a full refund. After the initial 24 hours are over any cancellation made up to 24 hours prior to the customer's scheduled transportation will result in the customer being charged 50% of their contracted price. Cancellations with less than 24 hours notice is non refundable, and will result in the customer being charged the full contracted price. In the unforeseeable event that Sin City Luxury Charters is unable to fulfill a transportation contract due to a mechanical problem a full and immediate refund will be given and an agent will assist in helping connect the customer to an alternative transportation company.

FAIR MINIMUM

A minimum of two (2) hours of fares must be paid to warrant service being offered. Charges will be computed on the bases of (a) the hourly rate or (b) the minimum charge, whichever results in the greater charge shall apply. The maximum capacity allowed on the bus is 70 people.
