APPLICATION OF CARRIERS OPERATING AUTHORITY

Fares and charges in this Tariff are limited in their application to the extent of Carrier's operating authority set forth in its CPCN, issued by the Nevada Transportation Authority. **RESTRICTED** to transportation in INTRASTATE Commerce only as a common carrier by motor vehicle, as follows:

ST GEORGE EXECUTIVE SHUTTLE L.L.C.

Passengers and their baggage in airport transfer service in Executive, Standard, and Economy vans and vehicles between Mesquite, Nevada and McCarran International Airport and within Clark County, Nevada.

Transportation of passengers in special services originating within the city limits of Mesquite on the one hand and points and places within Clark County Nevada on the other.

RULES AND REGULATIONS
APPLICATION AND REGULATIONS

Fares and charges named in this Tariff are stated in gross (commissionable) terms; and cover only ground transportation of passengers and their baggage, as provided in Carrier's operating authority in airport transfer service and special services.

Airport Transfer Service Operations apply only in Clark County to and from McCarran International Airport as provided in Section 1 of this Tariff.

Special Services for the transportation of passengers for special events and seasonal trips in Clark County as provided in Section 2 of this Tariff.

BAGGAGE

- A. Luggage not to exceed two (2) pieces and not to exceed fifty (50) pounds each in weight and one (1) carry-on per person will be carried without charge. Any additional luggage can be carried for a fee of \$5.00 per piece of luggage as space permits with arrangements made in advance. Carrier will not be responsible or liable for loss, theft, or damage to baggage or contents thereof.

BAGGAGE (continued)

- A. Passengers will not be permitted to board the vehicle with firearms, (unless the firearm is disassembled, or unloaded in a carrying case); explosives; inflammables; or any other article or substance which, in the opinion of the driver, could be harmful or obnoxious to fellow passengers.
- B. Passengers boarding a vehicle with sharp pointed tools or instruments will have such tools or instruments wrapped securely, and any pointed ends protected to prevent injury to other passengers.

PASSENGER BEHAVIOR AND OBJECTIONABLE PERSONS

Government issued photo ID is required of all adult passengers prior to boarding the shuttle. The Carrier reserves the right to refuse transportation to any person(s) under the influence of intoxicants or drugs, or is incapable of taking care of himself or herself, or when conduct is, or is likely to be objectionable to other passengers or prospective passengers. The driver of the vehicle shall have the right to require any passengers to leave the vehicle if the person or passenger is intoxicated, unruly, or who is believed to be under the influence of narcotics.

LIABILITY

The Carrier will not be liable for delays caused by an act of God, public enemy, authority of law, quarantine, riots, strikes, force majeure, accidents, breakdowns, unnavigable conditions of the road, storms and other conditions beyond its control; and does not guarantee to arrive at or depart from any point at a specified time. The Carrier will endeavor to maintain the shuttle schedule and schedule submitted by its agent or employee; and, over routes indicated, but the same is not guaranteed.

In the event any of the above conditions exist and, in the opinion of the Carrier, it is inadvisable to operate its equipment from the point of origin to any point in route, the Carrier shall not be liable therefore, or be held for damages for any reason whatsoever.

LIABILITY (continued)

The Carrier will not be responsible for, or liable to passengers, for personal articles lost by or stolen from passengers, or for damages to personal property.

CHILDREN

Children under twelve (12) years of age must be accompanied by an adult passenger and will be charged a full fare. Children who are five (5) years of age or younger must be in a car seat or booster seat. The Carrier does not provide the booster or car seat.

MINORS

The Carrier defines a minor as any passenger twelve (12) to seventeen (17) years old. A properly completed Parental Consent Form available from the Carrier is required for all minors. Minors are required to show school ID or a photocopy of birth certificate prior to boarding.

TRAVEL CREDIT

All fares are non-refundable. The Carrier does offer a travel credit to those passengers who cancel their reservation at least twenty-four (24) hours prior to departure. The travel credit is good for up to one (1) year from the date of the original booking date, and customer will be charged \$5 for changing the reservation.

FARES

All fares for passengers and their luggage in Airport Transfer Service are paid in advance of travel.

ANIMALS

The Carrier does not allow pets to travel except for ADA approved "Service Animals" subject to rules, limitations and restrictions of the Americans with Disabilities Act.

With the exception of the front seat, no reservations for seats will be made. The Carrier reserves to itself full control as to the seating of passengers, and reserves the right to change such seating at any time during the trip, provided, however, that seating arrangements will be made without regard to race, color, creed, sex or national origin. Carrier reserves the right to transfer passengers from one vehicle to another, at any time during the trip, whenever operating conditions require.

STOPOVERS

There are no stopover privileges by the Carrier for its passengers, except when such stopovers are an actual part of the itinerary. Passengers will be discharged only at points authorized in Carrier's respective Tariff.

CLAIMS FOR LOST OR DAMAGED FREIGHT OR BAGGAGE

A claim by a shipper or consignor against a common or contract motor carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered. Within 14 days after receipt of the claim, the carrier shall: (a) Compensate the shipper or consignor; or (b) deliver to the shipper or consignor a written denial of the claim.

A denial of a claim may be appealed by the shipper or consignor to the Authority.

3% TAX Pursuant to SECTION 51 of AB 175 N.T.A. #1

The following rules apply to carriers who provide passenger transportation, excluding airport transport service:

Pursuant to Nevada Legislative Senate Bill No. 376

Sec. 36. Section 51 of Assembly Bill No. 175 of this session is hereby amended to read as follows:

Sec. 51. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.

2. The provisions of subsection 1 do not apply to an airport transfer service.

3. (Intentionally omitted)

4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and places in this State. The term does not include charter services by bus, charter services by limousine, scenic tours or special services.

NOTE 1: The passenger transportation recovery charge must be passed along to all customers.

NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.
