APPLICATION OF TARIFF

- 1. Rule, Regulations, Rates, and Charges named herein apply to the transportation of passengers and their luggage by Stardust Limousine, Inc., between all points in Clark County and Nye County, Nevada as described in "Application of Carrier's Operative Rights" published herein.

BAGGAGE

- (a) Hand baggage not to exceed forty (40) pounds per adult passenger will be permitted.
- (b) No tools or articles with sharp edges will be carries unless securely and safely packaged and securely stowed within the vehicle.
- (c) No explosive, inflammables, or liquids which could contaminate or be harmful to passengers or equipment will be carried.

ANIMALS

15

Dogs, cats, or other live animals will not be carried unless properly confined in an approved container.

Exception: Seeing-eye dogs or similar animals in the performance of their duty to vision impaired persons.

RULES AND REGULATIONS

OBJECTIONABLE PEOPLE

25 Carrier reserves the right to refuse transportation to any person under the influence of intoxicants or drugs, appears incapable of taking care of himself or herself or when conduct is likely to be objectionable to other passengers, or to adversely affect the safe operation of the vehicle.

CARRIER'S LIABILITY

30 Carrier will not be liable for loss or damage to baggage or the contents thereof unless occasioned by lack of reasonable care on it's part, and then only for the reasonable value thereof, subject to a maximum liability of \$5,000.00 for the loss off, or damage to any single piece of baggage, including it's contents.

CLAIMS

35 Claims for loss or damage to baggage must be filed in writing with the carrier within seven (7) days after the loss or damage is discovered. Carrier shall, within fourteen (14) days after receipt of the claim, (a) Compensate the shipper or consignor; or (b) Deliver to the shipper or consigner a written denial of the claim. A denial of a claim may be appealed by the shipper or consignor to the (commission) transportation services authority.

COMPUTATION OF RATES

40 Hourly-rates named herein apply from the time the limousine is dispatched until it's returned to the point of dispatch. For purpose of this tariff, dispatch points are identified as Laughlin, Nevada.
