APPLICATION OF CARRIERS OPERATING AUTHORITY

Fares and charges in this tariff are limited in their application to the extent of carrier's operating authority set forth in certificate, issued by the Nevada Transportation Authority, RESTRICTED to transportation in INTRASTATE Commerce only as a common carrier by motor vehicle, as follows:

On Call over irregular routes, of Passengers in charter bus service, between points and places within the State of Nevada.

RULES AND REGULATIONS

APPLICATION OF TARIFF

Fares and charges named in this tariff are stated in gross (commissionable) terms; and cover only ground transportation of passengers and their baggage, as provided in Carrier's Operating Authority in transportation operations. Rates and charges provided in this tariff, for services as ordered, shall be prepaid, or paid by established accounts within 30 days of service. Charges for services in addition to the services ordered and previously pre-paid shall be paid within 48 hours of presentation of invoice or transportation bill to the debtor.

CHARTER OPERATIONS shall be conducted under charges as provided in this tariff.

BAGGAGE

Hand baggage, not to exceed eighty (80) pounds in weight for each fare ticket will be carried without charge. No baggage other than hand baggage will be carried on any trip. Carrier will not be liable for loss or damage to baggage or contents thereof unless occasioned by lack of reasonable care on its part and then only for the maximum liability of \$250.00 for the loss of, or damage to, any single piece of baggage, including its contents.

RULES AND REGULATIONS

ITEM

---

LIABILITY

The carrier will not be liable for delays 'caused by an act of God, public enemy, authority of law, quarantine, riots, strikes, force majeure, accidents, breakdowns, bad conditions of the road,, storms and other conditions beyond its control; and does not guarantee to arrive at or depart from any point at a specified time. The carrier will endeavor to maintain the schedule submitted by its agent or employee; and, over routes indicated, but the same is not guaranteed. 20

If any act of God, public enemy, authority of law, quarantine, perils of navigations, riots, strikes, the hazards or dangers incident to the state of war, accidents, breakdowns, bad conditions of the road, storms, and other conditions beyond its control make it, in the opinion of the carrier, inadvisable to operate its equipment either from the point of origin or any point en route, the carrier will not be held for damages for any reason whatsoever.

---

CLAIMS

A claim by a shipper or consignor against a common or contract motor carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered. Within 14 days after receipt of the claim, the carrier shall: 30  
(a) Compensate the shipper or consignor; or (b) deliver to the shipper or consignor a written denial of the claim.

A denial of a claim may be appealed by the shipper or consignor to the Authority.

---

OBJECTIONABLE PERSONS

The driver of the transit vehicle will have the right to refuse to carry any person or require any passenger to leave the vehicle if the person or passenger is intoxicated, unruly or who is believed to be under the influence of narcotics. 35

ANIMALS

Animals, other than "Seeing Eye Dogs" will not be carried unless properly crated. 40

---

PASSENGER AGENT

Carrier may elect to appoint as its agent any organization, firm, corporation, motel, hotel, or legal gaming operation, who individually or collectively, desire to obtain passenger bus transportation service between one or more common points for the collection of all applicable charges and remittance thereof direct to carrier without individual passenger fare collection by the carrier. 45

---

CANCELLATION FEE

A cancellation fee will be charged in the event that the request for transportation is canceled less than twenty-four (24) from time of cancellation notification to time of requested service. Cancellation with less than twenty-four (24) hours notice will be charged the full amount of the chartered service. 50

---

REFUNDS

Service requested must be cancelled by the booking party with a minimum of 24 hours notice in order to receive a full refund. Cancellation with less than 24 hours notice is not refundable. 55

---

FAIR MINIMUM

A minimum of one (1) hour of fares must be paid to warrant service being offered. 60

No person under the age of 18 will be permitted to take part in service, unless a parent, guardian or other responsible adult accompanies the minor. We define an *adult* any person who is over 18 years of age, or older, and who is responsible for the care and supervision of the child. 65

CHILDREN'S FARES

No child will have a reduced rate. No child will be allowed to sit in anyone's lap and children who require infant seats or child safety seats will be allowed on the provision that a responsible adult provides such a seat and installs that seat in the vehicle securing it with the vehicle's safety belts. 70

NON-DISCRIMINATING

Carrier will not refuse service to anyone because of race, creed, sex or national origin. 75

SEAT BELTS

All passengers will be required to fasten the vehicle's seat belts at any time the vehicle is in motion. Carrier reserves the right to refuse service to anyone who cannot, or will not, wear a seat belt. 80

SMOKING

Smoking will not be permitted in any of the carrier's vehicles. 90

APPLICATION

Charges shown in this section for Charter Services cover continuous or round trip transportation within the state of Nevada.

Charter Services will be conducted over paved, oil macadam roads, or roads over which earner's equipment can be operated with safety and without undue wear.

CHARTER SERVICES RATES AND CHARGES

The charges shown on Page 8 are for Charter, and/or On-Call, and/or Kelly Services, and cover continuous transportation, as well as the time the vehicle is rented and reserved for passenger use, preventing use for other clients' transportation.

All transportation requires one hour minimum, except for:  
International airport pick-ups: 1.5 hour minimum  
School dance/Prom: 5.0 hour minimum

Bookings will be charged in half hour increments after the first full hour of service. Any rate charged for any Charter, whether generated as an "On-Call" booking, or as a "Kelly Rate" booking, or any other Charter, automatically includes all the functional features of the particular vehicle, such as, a stereo, a television, a DVD player, disco lights, ice service, etc..

All rates are exclusive of accompanying staff, unless special arrangements for accompanying staff are made, (i.e., VIP host, greeters, models, interpreter, security or bodyguard, etc.) Added Amenities, not already included with any vehicle, are charged at cost, plus \$10.00 per amenity (i.e Flowers, balloons, mixers, juices, club soda, fog machine, special event tickets, catering services, meals, video/DVD rentals, karaoke machine, X-Box rentals, video games, luggage vehicle or trailer, child car seat, wheelchair, etc.) All amenities are based upon availability. Some amenity items will require advance arrangements.

There are no prices based on a "per person" basis. All prices are based on a "total vehicle" package price. Any toll charges, parking or other trip fees, and/or park entrance fees, are the responsibilities of the customer or client.

Rates and charges named in this tariff are applicable to waiting time, live service. Add deadhead time and or out of the area to the rates and charges names in this tariff, (i.e. required travel of the vehicle without passengers between the point of dispatch and the point of passenger pick-up or drop-off), except that there will be no charge time for transportation provided entirely within the Las Vegas Valley bounded by Hwy. 515/95 to the north and northeast; Desert Inn & Pecos to the east; Windmill Pkwy. And Blue Diamond to the south and Rainbow Blvd. to the west

Maximum driving time allowed by law is ten (10) hours per day, during any shift of up to twelve (12) hours. Therefore, any long distance 'round trip over five (5) hours driving one way, requires an overnight stay at the turning point, making the trip a two (2) day excursion.

Per Diem of \$100.00 plus \$35.00/hour waiting time will be charged in lieu of driver lodging and meal expenses for trips lasting 10hours or more. Driver Gratuities are not included. Any toll, parking or other trip fees, park entrance fees are responsibilities of the customer. Maximum driving allowed by law is 10 hours per day. Therefore, any long distance trip over 5-hours driving one way, requires overnight stay at turning point, making the trip two days.

While STARLIGHT TRANSPORTATION will attempt to adhere to time schedules specified by customers, they will not be liable for any damages from delays caused by acts of God, public enemies, authority of law, quarantine, perils of navigation, riots, strikes, and hazard or dangerous incident to a state of war, accidents, storms and any other conditions beyond its control. STARLIGHT TRANSPORTATION shall not be held liable for any damages caused by delays specified herein.
