RULES AND REGULATIONS

APPLICATION OF TARIFF

Fares and charges named in this tariff are stated in gross (commissionable) terms; and cover only ground transportation of passengers and their baggage, as provided in Carrier's Operating Authority in charter, airport transfer service, scenic tours and special services.

AIRPORT TRANSFER SERVICE OPERATIONS shall be conducted under charges as provided in Section 1 of this Tariff

SPECIAL SERVICE OPERATIONS apply only from and to points in Clark County, Nevada under fares as provided in Section 2 of this tariff. Fares will be limited to the trip and schedule as designated on the confirmation order.

SCENIC TOURS OPERATIONS shall commence at given points and places in Clark County, Nevada under fares as provided in Section 3 of this tariff. All passengers must be returned to points in Clark County, Nevada. Fares will be limited to the trip and schedule as designated on the ticket sold therefore.

CHARTER SERVICE IN BUSES shall be conducted under charges as provided in Section 4 of this Tariff.

BAGGAGE

Hand baggage, not to exceed 2 pieces and not to exceed on hundred pounds (100 lbs.) in weight for each fare ticket will be carried without charge. No baggage other than hand baggage will be carried on any trip. Carrier will not be liable for loss or damage to baggage or contents thereof unless occasioned by lack of reasonable care on its part for maximum liability of \$250.00 for the loss of, or damage to, any single piece of baggage, including its contents.

Rules & Regulations

CHILDREN'S & SENIOR FARES

Children under five (5) years of age when accompanied by an adult passenger and not occupying a seat to the exclusion of other passengers, will be carried without charge. Children under five (5) years of age occupying a seat to the exclusion of other passengers will be charged full fare for airport service, or special services on scenic tours. Senior citizens (62 years of age) will be entitled to a twenty (20%) reduction from the approved scenic tours tariff.

LIABILITY

The carrier will not be liable for delays caused by an Act of God, public enemy, authority of law, quarantine, riots, strikes, force majeure, accidents, breakdowns, bad conditions of the road, storms and other conditions beyond its control; and does not guarantee to arrive at or depart from any point at a specific time. The carrier will endeavor to maintain the schedule submitted by its agent or employee; and, over routes indicated, but the same is not guaranteed

If any act of God, public enemy, authority of law, quarantine, perils of navigations, riots, strikes, the hazards or dangers incident to the state of war, accidents, breakdowns, bad conditions of the road, storms, and other conditions beyond its control make it in the opinion of the carrier, inadvisable to operate its equipment from the point of origin or any point en route the carrier shall not be liable therefore, or be caused to be held for damages for any reason whatsoever.

CLAIMS

A claim by a shipper or consignor against a common or contract motor carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered. Within 14 days after receipt of the claim, the carrier shall: (a) Compensate the shipper or consignor; or (b) Deliver to the shipper or consignor a written denial of the claim. A denial of a claim may be appealed by the shipper or consignor to the Authority.

OBJECTIONABLE PERSONS

The driver of the transit vehicle shall have the right to refuse to carry any person or require any passenger to leave the vehicle if the person or passenger is intoxicated, unruly or who is believed to be under the influence of narcotics.

ANIMALS

Animals, other than "Seeing Eye Dogs" will not be carried.

PASSENGER AGENT

Carrier may elect to appoint as its agent any organization, firm, corporation, motel, hotel, or legal gaming operation, who individually or collectively desire to obtain passenger bus transportation service between one or more common points for the collection of all applicable changes and remittance thereof direct to carrier without individual passenger fare collection by the carrier.

Upon request, carrier will provide any tour group comprised of the minimum number of passengers stated in the Tariff with the exclusive occupancy of vehicle furnished.	100
PASSENGER BEHAVIOR	
The Carrier will refuse to carry a passenger or will remove, at any proper point en route, any person whose, physical or mental behavior, is such, as to render him incapable of caring for himself without assistance, render him objectionable to other passengers, or involve any hazard or risk to other persons or property being transported. <i>EXCEPTION: This item does not apply to persons who are ill and are accompanied by attendant or nurse.</i>	110

3% TAX Pursuant to SECTION 51 of AB175

The following rules apply to carriers who provide passenger transportation, excluding airport transport service.

Pursuant to Nevada Legislative Senate Bill No. 376

Sec. 36. Section 51 of Assembly Bill No. 175 of this session is hereby amended to read as follows:

Sec. 51. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.

2. The provisions of subsection 1 do not apply to an airport transfer service.

3. (Intentionally omitted)

4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and place in this State. The term does not include charter services by bus, charter services by limousine, scenic tours or special services.

NOTE 1: The passenger transportation recovery charge must be passed along to all customers.

NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above
