Service to be provided during the months of March, April, May, June, July, August, September, October and November ONLY. Services during the months of December, January and February as weather permits.

APPLICATION OF FARES

Fares shown herein are in Dollars and Cents and are payable in lawful money of the United States.

10

FARES

Per Person:

Any person thirteen (13) years of age or older will be considered an adult and will be levied a fare of \$6.00.
 Any child between five (5) and twelve (12) years of age will be levied a fare of \$3.00.
 Any child four (4) years or under, accompanied by an adult over eighteen (18) years old will be carried for free.
 Any senior 60 years of age or older will be levied a fare of \$5.00.
 Any group of fifteen (15) or more adults and/or children will be levied a fare of \$4.00 per adult and \$2.00 per child.
 To qualify for the group rate one person will pay the fare for the group and notify Virginia City Tours, Inc. of their arrival in advance.

Charter Service:

Vehicles with a passenger capacity of 20 - 32

EXCEPTIONS TO FARES

ANIMALS

Live animals will not be carried in the coach with passengers except service animals.

40

FIREARMS

Passengers will not be permitted to board the coach with guns.

45

BAGGAGE

Passengers will be permitted to board the coach with small types of baggage including: purses, cameras and camera cases, cell phones, small handbags, and shopping bags.

NAC 706.333 Claims for lost or damaged freight or baggage. (NRS 706.171)

1. A claim by a shipper or consignor against a common or contract motor carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered.

2. Within 14 days after receipt of the claim, the carrier shall:

(a) Compensate the shipper or consignor; or (b) Deliver to the shipper or consignor a written denial of the claim.

3. A denial of a claim may be appealed by the shipper or consignor to the Authority.

RIGHTS RESERVED

(a) Virginia City tours reserves the right to refuse transportation to any and all persons having in their possession explosive or inflammable material or articles of substances of any objectionable nature; or who are under the influence of liquor or drugs, or are incapable of taking care of themselves, or whose conduct or behavior is objectionable to either passengers or prospective passengers. In such cases, where the fare has been paid, same will be redeemed.

(b) Virginia City Tours reserves full control and discretion as to seating of passengers and the right to change such seating at any time during the trip.

(c) All passengers will, at all times, remain seated and keep arms, legs and heads within the coach.

(d) No passenger will be allowed to throw anything from the coach.

(e) If any passenger conducts himself, or herself, in any offensive manner, including using loud or profane language, Virginia City Tours shall have the right to remove the passenger from the coach immediately, and at that time shall furnish a redemption of the fare.

(f) There shall be NO SMOKING on the coach.
