GENERAL DESCRIPTION OF SERVICES

Viva Services, LLC owns and operates one (1) van that can seat up to seven (7) passengers plus one (1) driver. Accordingly, this vehicle meets the definition of "Traditional Limousine" under NAC §706.124(2). Viva Services, LLC will engage in the business of providing scenic tours for Japanese and Oriental tourists only. Viva Services, LLC will take Japanese and Oriental visitors on guided tours to points of interest in Nevada. Finally, since many of Viva Services, LLC customers may speak limited English, the owners of Viva Services, LLC are fluent in both Japanese and English.

SPECIFIC AUTHORITY REQUESTED

Viva Services, LLC respectfully requests that the Transportation Services Authority of Nevada issue Viva Services, LLC a Certificate of Public Convenience & Necessity ("CPCN") to engage in scenic tours as defined in NAC §706.112. The transportation of passengers and their luggage shall be "on-call" and over "irregular routes."

APPLICATION OF CARRIER'S OPERATIVE RIGHTS

Fares and charges in this tariff are limited to their application to the extent of carrier's operating authority set forth in certificate, issued by the Transportation Services Authority of Nevada, RESTRICTED to transportation in INTRASTATE Commerce only as a common carrier of passengers, as follows: VIVA SERVICES LLC, a Certificate of Public Convenience and Necessity for the transportation of passengers and their baggage in on-call transportation of scenic tours over irregular routes between points and places within the State of Nevada.

APPLICATION OF TARIFF

Fares and charges named in this tariff are stated in gross terms; and cover only ground transportation of passengers and their baggage. Rates and charges provided in this tariff, for services as ordered, shall be prepaid or paid by established accounts within 30 days of service. Charges for services in addition to the services ordered and previously prepaid shall be paid within 24 hours of presentation of invoice or transportation bill to debtor.

**RULES AND REGULATIONS**

BAGGAGE

Hand baggage, not to exceed seventy-five (75) pounds in weight for each fare ticket will be carried without charge. No baggage other than hand baggage will be carried on any trip. Carrier will not be liable for loss or damage to baggage or contents thereof unless occasioned by lack of reasonable care on its part and then only for the maximum liability of \$50.00 for the loss of, or damage to, any single piece of baggage, including its contents.

CHILDREN'S FARES

Children under two (2) years of age when accompanied by an adult passenger will be carried without charge. Children between two (2) to eleven (11) years of age occupying seats to the exclusion of other passengers will be charged half fare. Children age twelve (12) and older will be charged full fare.

CLAIMS

Unless otherwise prescribed by law, all claims of any nature must be filed in writing with carrier within ninety (90) days.

ANIMALS

Animals, other than dogs used by persons with a visual disability, will not be carried.

RIGHT TO REFUSE

The driver of the vehicle will have the absolute right to refuse to carry any person(s) or require any passenger(s) to leave the vehicle if the person(s) or passenger(s) is intoxicated, unruly, violent, disruptive, or believed to be under the influence of narcotics.

CANCELLATION FEE

Carrier reserves the right to charge a cancellation fee in the event that the request for transportation is canceled less than twenty-four (24) hours from the time of requested service. The fee charged shall be the full fare of the transportation service.

SEATBELT

All passengers occupying a seat must wear a seatbelt.

PROHIBITED USES

Smoking of cigarettes, cigars, and pipes is prohibited while passenger is in van. Alcohol consumption is also prohibited while passenger is in van.

LIABILITY

The carrier will not be liable for delays caused by an act of God, public enemy, authority of law, quarantine, riots, strikes, accidents, breakdowns, bad conditions of the road, storms, and any other conditions beyond its control. Carrier does not guarantee to arrive at or depart from any point at a specified time. The carrier will make all efforts to maintain the schedule submitted by its agent or employee; and, over routes indicated but the same is not guaranteed.

If any act of God, public enemy, authority of law, quarantine, riots, strikes, accidents, breakdowns, bad conditions of the road, storms, and any other conditions beyond the control of the carrier make the trip, in the opinion of the carrier, inadvisable to operate its equipment either from point of origin or any point en route, the carrier will not be held liable for any damages.
