RULES AND REGULATIONS

5 APPLICATION OF TARIFF

Carrier operates an on-call commercial transportation company, over irregular routes using a charter bus to provide intrastate passenger transportation in the form of charter bus service from points and places within the State of Nevada.

10 COMPUTATIONS OF RATES AND CHARGES

Rates and charges are identified herein and pertain specifically to Charter Bus services provided by charter on an hourly basis consistent with the authorized authority as granted by the Nevada Transportation Authority. A minimum of one and a half hours will be charged on trips outside the Las Vegas corridor.

15 BAGGAGE

- a) Hand baggage shall not exceed forty (40) pounds per each bag per adult passenger;
- b) Articles with sharp edges will not be carried unless securely and safely packaged;
- c) Explosives, inflammables, or harmful liquids will not be transported.

25 OBJECTIONABLE PERSONS

Carrier reserves the right to refuse transportation to any persons under the influence of intoxicants or drugs, or incapable of taking care of himself or herself, or whose conduct is likely to be objectionable to other passengers.

Exception: Incapacitated or ill persons accompanied by a nurse or guardian.

RULES AND REGULATIONS

30 LIABILITY

Pursuant to NAC 706.333, a claim by a shipper or consignor against a common motor carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered. Thereafter, within 14 days after receipt of the claim, the carrier shall either: (a) compensate the shipper or consignor; or (b) deliver to the shipper or consignor a written denial of the claim. A denial of a claim may be appealed by the shipper or consignor to The NTA.

Carrier will not be liable for loss or damage to baggage or their contents, unless such loss or damage is caused by lack of responsible care, and then only for the reasonable value thereof, subject to a maximum liability to \$250.00 for the loss of, or damage to, any single piece of baggage, including its contents.

50 CANCELLATION

Abraham Limo Service Inc. reserves the right to charge a cancellation fee in the event that the request for transportation is canceled less than forty-eight 48 hours from the time of cancellation notification to the time of requested service. Cancellation with less than twenty-four (24) hours' notice will be charged the full amount of the charter order. Abraham Limo Service Inc. requires a 7 day cancellation policy for all Federal Holidays & Special Events and a charge of 50% non-refundable deposit on all transportation reservations.

CHARGES & ON-CALL SERVICES – RATES & CHARGES

CHARTER BUS SERVICES

Note 1: Airport Vehicle Search Fee: A fee of \$3.00 per vehicle per security check will apply to all charter service where the Carrier is required to pay an airport vehicle search fee to the Clark County Department of Aviation.

Note 2: Airport Parking / Toll Fee: A fee of \$10.00 per vehicle will apply to all charter service where the carrier is Required to pay an airport parking fee to the Clark County Department of Aviation.

Note 3: Airport Assistance Fee (Meet & Greet): A fee of \$10.00 per vehicle will apply to all charter service where the driver required to meet passengers inside the airport to assist them with their luggage and escort them to the Vehicle.

Note 4: Amenities Fee: A fee of \$20.00 per vehicle will apply to all charter service will be at cost plus the cost of the amenity

Note 5: Charter & On-Call Services Rates & Charges

- a. The charges shown below are for Charter, and/or On-Call, and/or Walk-On Services and cover continuous transportation As well as the time the vehicle is rented and reserved for passenger use, preventing use for other client's transportation.
- b. All transportation requires one hour minimum with half hour increase thereafter, except for:
 - Airport pickups and drop offs are one and 1/2 hour minimum
 - Federal and State Holidays is 3 hours minimum
 - Special events such as prom, homecomings, school dances are 6 hours minimum
 - NASCAR is 10 hours minimum
 - CES and CONEXPO is 12 hours minimum
- c. Bookings will be charge in half hour increments after the first full hour of service. Any rate charged for any Charter, whether generated as an "On-Call" booking, or as a "Walk-On Rate" booking, or any other Charter, automatically includes all the functional features of the particular vehicle, such as a Stereo, television, DVD player, ambient lights, ice service, etc. The hourly charge for any vehicle is per hour, plus fuel surcharges and amenities.
- d. All rates are exclusive of accompanying staff, unless special arrangements for accompanying staff are made. (i.e. VIP Host, tour guide, greeters, models, interpreter, security or bodyguard, etc.) Added Amenities are at cost, plus \$20 per amenity, (i.e. flowers, balloons, birthday gifts, cards, cameras, fruit baskets, non-alcoholic beverages, mixers, juices, club soda, bottle water, special events tickets, catering services, meals, video/DVD rentals, karaoke machine, X-Box rentals, video games, luggage vehicle or trailer, child car seat wheelchair, etc.) All amenities are based upon availability. Some amenity items will require advance arrangements.

PRICING SCHEDULE

FOR CHARTER RATES AND/OR ON-CALL RATES AND/OR WALK-ON RATES

- h. Maximum driving time allowed by law is ten (10) hours per day shift of up to (12) hours. Therefore, any long distance 'round trip over (5) hours driving one way, requires an overnight stay at the turning point, making the trip a (2) day excursion.
- i. Per Diem of \$100 plus \$35 per hour waiting time will be charged in lieu of driver lodging and meal expenses for trips lasting 10 hours or more. Driver gratuities are not included. Any toll, parking or other trip fees, park entrance fees are responsibilities of the customer.
- j. Carrier may pay a commission or referral fee to an agent, broker, travel agent or tour operator who arranges for the provision of transportation by the carrier to a third party so long as they commission fee does not exceed 10% of the applicable rate or charges specified in this here tariff.
- k. While Abraham Limo Service will attempt to adhere to time schedules specified by customers, they will not be liable for any damages from delays caused by acts of God, public enemies, authority of law, quarantine, perils of navigation, riots, strikes, and hazard or dangerous incident to a state of war, accidents, storms and any other conditions beyond its control. Abraham Limo Service shall not be held liable for any damages caused by delays specified herein.

FUEL SURCHARGE TABLE AND RULES

The following Gasoline Fuel-Related Cost Price Adjustment (Surcharge) will apply on Charter Bus Service Charges, as described below.

- a. The price of regular and diesel fuel is an amount equal to the retail price per gallon of regular and diesel fuel effective on the 25th calendar day of the immediate preceding month, determined according to the United States Department of Energy, (DOE). Energy Information Administration's (EIA) survey on Weekly Retail Gasoline and Diesel Prices, Regular Grade – West Coast (PADD 5) and Weekly Retail Gasoline and Diesel Prices, Diesel, All Types – West Coast (PADD 5). The prices may be obtained by calling the DOE. EIA at (202) 586-8800 or via the DOE, EIA website at www.eia.doe.gov via the "Petroleum" Link.
- b. If the 25th day of the calendar month is a Federal holiday, the fuel price will be determined based on the stated DOE price available on the next subsequent business day.
- c. The DOE fuel price obtain will then be indexed based on the price matrix set forth below to determine the fuel surcharge. The fuel surcharge will apply for all charter bus transportation beginning on the 1st day of the following month and will remain in effect through the last day of that calendar month.
- d. The fuel surcharge will be added on hourly basis utilizing the matrix set forth below. The resulting charge is in addition to all other applicable transportation charges.

When the DOE Fuel Price Per Gallon reported on the 25 th of the month is:	The Fuel Cost Adjustment Factor that becomes effective on the 1 st day of the following month is:

\$ 2.65 - \$ 3.00	10%

NOTE 1: The fuel surcharge that is applicable for a given month must be passed along to all customers.

NOTE 2: The fuel cost price adjustment will be shown separately from the charter revenue on carrier transportation documents for the purpose of identifying the amount as special fuel-related revenue.
