1. A claim by a shipper or consignor against a common or contract motor carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered.
2. Within 14 days after receipt of the claim, the carrier shall:
  - (a) Compensate the shipper or consignor; or
  - (b) Deliver to the shipper or consignor a written denial of the claim
3. A denial of a claim may be appealed by the shipper or consignor to the Authority

RIGHTS RESERVED

- a. This company reserves the right to refuse transportation to any and all persons having in their possession explosives of inflammable material or articles or substances of an objectionable nature; or who are under the influence of liquor or drugs, or whose conduct or behavior is objectionable to either passengers or prospective passengers.

**RATES FOR MULTIPLE PASSENGERS**

If more than one passenger requiring special transportation is transported in the vehicle at the same time, then the rate charged each passenger so transported shall be three quarters of the applicable rate for his/her transportation as specified above.

There shall be no charge for passengers not requiring special transportation who accompany a passenger requiring special transportation.

Curbside service is that service provided when, by prearrangement, the passenger is picked up at curbside and delivered to curbside at the destination. This service does not require the driver to enter any facility in order to complete the transport. Under these conditions a 10% reduction of the full service rate applies.

77

Ambulatory service is defined as transportation of a passenger who is able to work without assistance from the driver, and is able to enter and exit the vehicle under his/her own power or with minimal assistance. Storage space for any walking aids such as walking sticks, walkers, or crutches will be available in each vehicle.
