**RULES AND REGULATIONS
APPLICATION OF TARIFF**

Fares and charges named in this tariff are stated in gross (commissionable) terms, and cover only ground transportation of passengers and their baggage, as provided in Carrier's Operating Authority in transportation operations. Rates and charges provided in this tariff, for services as ordered, shall be prepaid or paid by established accounts within 30 days of service. Any late payments will be subject to a 10% late fee. Charges for services in addition to the services ordered and previously prepaid shall be paid within 24 hours of presentation of invoice of transportation bill to debtor

BAGGAGE

Hand baggage, not to exceed one hundred (100) pounds in weight for each fare ticket will be carried without charge. No baggage other than hand baggage will be carried on any trip. Carrier will not be liable for loss or damage to baggage or contents thereof unless occasioned by lack of responsible care on its part and then only the maximum liability of \$50.00 for the loss of, or damage to, any single piece of baggage, including its contents

ITEM

The carrier will not be liable for delays caused by an act of God, public enemy, authority of law, quarantines, riots ,strikes, force majeure, accidents, breakdowns, bad conditions of road, storms and other conditions beyond its control and does not guarantee to arrive at or depart from any point at a specified time. The carrier will endeavor to maintain the schedule submitted by its agent or employee and over routes indicated by the same is not guaranteed.

If any act of God, public enemy, authority of law, quarantine, perils of navigation, riots strikes, the hazards or dangers incidents to the State of War, accidents, breakdown, bad conditions of road storms and other conditions beyond its control make it , in the opinion of the carrier, inadvisable to operate its equipment either from the point of origin or any point en route, the carrier will not be held for damages for any reason whatsoever

CLAIMS

1. A claim by a shipper or consignor against a common or contract mortar carrier for lost or damaged freight or baggage must be submitted to the carrier within 7 days after the loss or damage is discovered
2. Within 14 days after receipt of the claim, the carrier shall:
 - a. compensate the shipper or consignor : or
 - b. Deliver to the shipper or consignor written denial of the claim
3. A denial of a claim may be appealed by the supper or consignor to the Authority
