APPLICATION OF TARIFF:

Rules, Regulations, and Rates for minimum loads named in this tariff apply to the transportation of passengers in sightseeing tours between points and places in Clark County, Nevada

MINIMUM LOAD REQUIREMENT AND COMPUTATION OF RATE

Carrier requires a minimum load, comparable to 4 adult fares, in order to operate a tour. Carrier will operate with one passenger if participant agrees to pay the minimum load rate (4 adult fares)

Carrier will operate with a single adult and child if passenger agrees to pay the minimum load rate (4 adult fares)

CHILDREN'S FARES AND COMPUTATIONS

Once the minimum load rate is met (4 adult fares), children (12 years and under) and are accompanied by a responsible party (18 years or older) are charged the children's rate.

ACCEPTANCE OF CHILDREN

Children under 18 years must be accompanied by an adult. An adult is classified as an individual 18 years or older who is responsible for the child during the tour. Each child must occupy a seat with a separate seat belt. Carrier will not accept lap children for transportation.
