Children under five (5) years of age occupying seats to the exclusion of other passengers will be charged full fare. STOPOVER PRIVILEGES 30 No stopover privileges will be permitted. CARRIER'S LIABILITY Carrier will not be liable for loss or damage to baggage or the contents thereof unless occasioned by 35 lack of reasonable care on its part, and then only for the reasonable value thereof, subject to a maximum liability of \$250.00 for the loss of, or damage to, any single piece of baggage, including its contents. **CLAIMS** Claims for loss of baggage must be communicated to the carrier at the time the passenger arrives at his/her final destination. The passenger will have 24 hours to submit a supporting written claim. The 40 carrier shall have a reasonable time in which to locate the lost baggage before making settlement, which will be not less than ten (10) days after being notified of such loss. Claims for damage to baggage or contents thereof must be filed in writing with the carrier within ten (10) days after the baggage was delivered to the customer. **DEPARTURE** The departure of a livery limousine from McCarran International Airport may be delayed, at the 45 discretion of the carrier, until a minimum of four fare-paying passengers have boarded, in each instance. In no instance shall departure be delayed more than 15 minutes after the boarding of the first passenger. PRE-ARRANGEMENT Fares for airport transfer service utilizing traditional limousines requires either online prepaid purchase \*50 of a voucher, for round-trip transportation only, from an authorized online travel wholesaler (e.g. Expedia), or from the Company's website, call center or airport sales booth, prior to the passenger's intended use of the voucher. The voucher must specify the date and time of the purchase. Upon the passenger entering the vehicle, the driver shall collect the prepaid voucher stub from the passenger and make it available for inspection by agents of the Nevada Transportation Authority.
