**DISCRIPTION OF OFF ROAD TOURS** (See also; Maps)

Tours to the Red Rock Canyon area shall proceed south on Interstate 15, Industrial Road or Las Vegas Blvd. to Route 160, then west on Route 160. Exit "off-road" in the Red Rock Canyon area on desert trails approved by the Bureau of Land Management (BLM).

Tours to the Valley of Fire area shall proceed north on Interstate 15 to the Valley of Fire State Park Exit or Ute Exit, then "Off-Road" on desert trails approved by the Bureau of Land Management (BLM).

- (N) Tours to the Nelson-Eldorado Canyon area shall proceed South on Route 95 at Railroad Pass to Nevada Road 165, then southeast to Nelson, then "off-road" on desert trails approved by the Bureau of Land Management (BLM).

**RESTRICTIONS:**

Vehicles utilized in the service shall have adequate signage identifying the company as on off-road scenic tour company. All trips and/or tours must contain a significant portion of travel off-road, on unimproved and unpaved roadways or tails, and that portion of off-road travel will occur in the middle of the trip/tour. The use of Paved roads in the greater Las Vegas, Henderson, and Clark County areas will only be for the purpose of transporting the vehicle and its passengers to and from an off-road tour.

Tours of Clark County are not to include the casino/hotels areas, including, but not limited to, the Las Vegas Strip (Las Vegas Boulevard) and the Fremont Street Experience, except to pick up and drop off passengers.

No passengers are to be picked up of dropped off at McCarran International Airport.

Rule No. Rules & Regulations

1. MINIMUM LOAD REQUIREMENTS:

A minimum of two adult fares must be paid to warrant a tour being offered. IF less than two individuals request that a tour be offered, that individual would be required to pay the full fare as though there were two individuals.

2. UNACCOMPANIED CHILDREN:

No person under the age of 16 will be permitted to take part in any tour unless they are accompanied by a parent, guardian, or other responsible adult.

3. INFANTS:

No children will be allowed to sit in a parent's lap. Infants and other children that require infant seats or child safety seats will be allowed on the provision that the parent or adult provides such seat and install said seat in the vehicle using the vehicle safety belts.

4. ALCOHOLIC BEVERAGES; AND/OR NON-PRESCRIPTION DRUGS

(C) No alcoholic beverages or non-prescription drugs will be allowed on any tour.

5. RIGHT TO REFUSE SERVICE:

The carrier reserves the right to refuse service to anyone who may appear to be under the influence of alcohol and/or drugs. They also reserve the right to refuse service to anyone who may display an inability to care for themselves or displays conduct which may disrupt the pleasure and safety of passengers or employees. 100% fee will be charged if a customer is refused service because he/she appears to be under the influence of alcohol or drugs or if he/she is refused service because he/she displays an inability to care for themselves or displays conduct which may disrupt the pleasure and/or safety of passengers or employees.

6. SEAT BELTS:

All passengers will be required to wear and fasten seat belts when the vehicle is in motion. Any person who refuses to wear a seat belt will be returned to the terminal without refund of charges.

7. TOUR CANCELLATION OR REROUTING:

The carrier reserves the right to cancel or reroute any given tour when weather conditions and or health hazards may affect the safety of passengers or employees. If a tour does not meet the minimum load requirements for reasons beyond our control, such as last minute cancellations, we reserve the right to cancel, reroute or reschedule the tour.

8. SMOKING IN VEHICLES:

Smoking will not be allowed in the vehicles. Frequent stops will be made to accommodate our smoking customers.

9. NON-DISCRIMINATION:

The carrier will not refuse service to anyone because of race, color or creed.

10. DISCOUNTS:

(N) Once the minimum adult load requirements have been met, a 25% discount will be allowed for children under 12 yrs. Of age. Seniors over 62 years of age will also receive a 10% discount.

11. APPLICATION OF RATES:

Rates are listed on page 6. The time length of the tour will be determined from "pickup" site to "drop-off" site.

12. REFUNDS:

(C) Tours canceled by the customer at least 48 hours prior to the tour date will be refunded a 100% of their deposit. If cancelled within 48 hours, a 50% refund would be allowed. If Bobcat Tours cancels a trip for any reason, mechanical failure or inadequate load requirements, and 100% refund would be allowed. Bobcat Tours reserves the right to cancel a tour. Cancellations less than 24 hours prior to trip time will result in a 100% charge.

13. SCHEDULE:

Tours are everyday of the week (except Christmas Day when no tours are offered).  
Two tours daily, pickup and departing at approximately 9 A.M and 2 P.M.

14. LENGTH OF TIME PER TOUR:

(N) Each Red Rock Canyon tour will last approximately three hours.  
Each Valley of Fire area tour will last approximately five to six hours.  
Each Nelson-Canyon Eldorado tour will last approximately four hours.

**3% TAX Pursuant to SECTION 51 of AB175**

The following rules apply to carriers who provide passenger transportation, excluding airport transport service:

**Pursuant to Nevada Legislative Senate Bill No. 376**

**Sec. 36. Section 51 of Assembly Bill No. 175 of this session is hereby amended to read as follows:**

Sec. 51. 1. Except as otherwise provided in subsection 2 and in addition to any other fee or assessment imposed pursuant to this chapter, an excise tax is hereby imposed on the connection, whether by dispatch or other means, made by a common motor carrier of a passenger to a person or operator willing to transport the passenger at the rate of 3 percent of the total fare charged for the transportation, which must include, without limitation, all fees, surcharges, technology fees, convenience charges for the use of a credit or debit card and any other amount that is part of the fare. The Department of Taxation shall charge and collect from each common motor carrier of passengers the excise tax imposed by this subsection.

2. The provisions of subsection 1 do not apply to an airport transfer service.

3. (Intentionally omitted)

4. As used in this section, "airport transfer service" means the transportation of passengers and their baggage in the same vehicle, except by taxicab, for a per capita charge between airports or between an airport and points and places in this State. The term does not include charter services by bus, charter services by limousine, scenic tours or special services.

NOTE 1: The passenger transportation recovery charge must be passed along to all customers.

NOTE 2: The 3% passenger transportation recovery charge must be shown separately from the total fare as defined above.
