**APPLICATION OF CARRIERS OPERATING AUTHORITY**

Fares and charges in this tariff are limited in their application to the extent of carriers operating authority set forth in certificate, issued by the Nevada Transportation Authority, RESTRICTED to transportation in INTRASTATE Commerce only as a common carrier by motor vehicle, as follows:

*Transportation of passengers in scenic tour service within Clark County Nevada.*

*RESTRICTIONS: The maximum number of charter buses used to provide scenic tour service shall be no more than the twenty-four (24) vehicles.*

**BAGGAGE**

Hand baggage, not to exceed 2 pieces and not to exceed 100 pounds in weight for each person will be carried. No baggage other than hand baggage will be carried on any trip. Carrier will not be liable for loss or damage to baggage or contents thereof unless occasioned by lack of reasonable care on its part for a maximum liability of \$250.00 for the loss of, or damage to any single piece of baggage including its contents.

ITEM

**CHILDREN FARES**

Children under three (3) years of age when accompanied by an adult passenger and not occupying a seat to the exclusion of other passengers will be carried without charge. Children under three (3) years of age occupying a seat to the exclusion of other passengers will be charged full fare for scenic tours.

**LIABILITY**

The carrier will not be liable for delays caused by an act of God, public enemy, authority of law, quarantine, riots, strikes, force majeure, accidents, breakdowns, bad conditions of the road, storms, and other conditions beyond its control; and, does not guarantee to arrive at or depart from any point at a specified time. The carrier will endeavor to maintain the schedule submitted by its agent or employee; and, over routes indicated, but the same is not guaranteed.

If any act of God, public enemy, authority of law, quarantine, perils of navigation, riots, strikes, the hazards or dangers incident to the state of war, accidents, breakdowns, bad conditions of the road, storms, and other conditions beyond its control make it, in the opinion of the carrier, inadvisable to operate its equipment either from the point of origin or any point en route, the carrier shall not be liable therefor, or be caused to be held for damages for any reason whatsoever.

**CLAIMS (NAC 706.333)**

A claim for lost or damaged baggage must be submitted within 7 days after the lost or damage is discovered. Within 14 days after receipt of the claim, the carrier shall (a) Compensate the shipper; or (b) Deliver to the shipper a written denial of the claim. 3. A denial of a claim may be appealed by the shipper to the Nevada Transportation Authority.

**OBJECTIONABLE PERSON**

The driver of the vehicle shall have the right to refuse to carry any person or require any passenger to leave the vehicle if the person or passenger is intoxicated, unruly or who is believed to be under the influence of narcotics.

**ANIMALS**

Animals, other than "Seeing Eye Dogs" will not be carried.

**PASSENGER AGENT**

Carrier may elect to appoint as its agent any organization, firm, corporation, motel, hotel, or legal gaming operation, who individually or collectively, desire to obtain Limousine transportation service between one or more common points for the collection of all applicable charges and remittance thereof direct to carrier without individual passenger fare collection by the carrier.

**DEFINITION OF "MINIMUM FARE"**

**ITEM**

The "Minimum Fare" column shown in Tariff means: When less than the number of full per seat fares, indicated in the minimum Fare column, are available at the scheduled departure time, for any transportation service covered by this Tariff, the carrier will perform the service for the sum of the minimum number of full per seat fares shown, or will cancel the tour; and will offer the passengers a full refund.

**EXCLUSIVE OCCUPANCY**

Upon request, carrier will provide any tour group comprised of the minimum number of passengers stated in the Tariff with the exclusive occupancy of vehicle furnished.

**PASSENGER BEHAVIOR**

The carrier will refuse to carry a passenger or will remove, at any proper point enroute, any person whose, physical or mental behavior, is such, as to render him incapable of caring for himself without assistance, render him objectionable to other passengers, or involve any hazard or risk to other persons or property being transported. *EXCEPTION: This item does not apply to persons who are ill and are accompanied by attendant or nurse.*

**REARRANGEMENT OF TOUR ROUTE**

Any itinerary may be altered, reversed or rearranged in sequence at the option of the carrier, provided that no points of interest are omitted; unless there is specific cause such as road hazards etc.

**RESERVATIONS**

Reservations of certain seats will not be made. The carrier reserves to itself full control as to the seating of passengers, and reserves the right to change such seating at any time during the trip; provided, however, that seating arrangements will be made without regard to race, color, creed, sex, or national origin. Carrier reserves the right to transfer passengers from one vehicle to another, at any time during the trip, whenever operating conditions require.

**STOPOVERS**

There are no stopover privileges on any Scenic Tour performed by the carrier for its passengers, except when such stopovers are an actual part of the itinerary. Passengers will be discharged only at points authorized in carrier respective Certificate of Public Convenience and Necessity
