APPLICATION OF CARRIER'S OPERATIVE RIGHTS

Fares and charges in this tariff are limited in their applications to the extent of carrier's operating authority set forth in certificate, issued by the Transportation Service Authority of Nevada, RESTRICTED to transportation in INTRASTATE Commerce only as common carrier by motor vehicle, as follow:

On call over irregular routes, of Passengers
In Charter bus service, between points and within the State of Nevada

APPLICATION OF TARIFF

Fares and charges named in this tariff are stated in gross (commissionable) terms; and cover only ground transportation of passenger and their baggage, as provided in Carrier's Operating Authority in charter operations. Rates and charges provided in this tariff, for services as ordered, shall be prepaid or paid by established accounts within 30 days of service. Charges for services in addition to the services ordered and previously prepaid shall be paid within 24 hours of presentation of invoice or transportation bill to debtor.

BAGGAGE

Hand baggage, not to exceed seventy (70) pounds in weight for each fare ticket will be carried without charge. No baggage other than hand baggage will be carried on any trip. Carrier will not be liable for loss or damage to baggage or contents thereof unless occasioned by lack of reasonable care on its part and then only for the maximum liability of \$20.00 for the loss of, or any single piece of baggage, including its contents.

RULES AND REGULATIONS

- 1) **CLAIMS** - Unless otherwise prescribed by law, all claims of whatsoever character must be filed in writing with carrier within Ninety (90) days.
- 2) **ANIMALS** - Animals, other than "Seeing Eye Dogs" will not be carried unless properly confined.
- 3) **OBJECTIONABLE PERSONS**
The driver of the transit vehicle will have the right to refuse to carry any person or require any passenger to leave the vehicle if the person or passenger is intoxicated, unruly or is believed to be under the influence of narcotics.

4) **PASSENGER AGENT**

Carrier may elect to appoint as its agent any organization, firm, corporation, motel, hotel or legal gaming operations, who individually or collectively, desire to obtain passenger bus transportation service between one or more common points for collection of all applicable charges and remittance thereof direct to carrier without individual passenger fare collection by the carrier.

5) **CANCELLATION FEE**

Carrier reserves the right to charge a cancellation fee in the event that the request for transportation is canceled less than Twenty-Four (24) hours from time of cancellation notification of time of requested service. This fee shall be \$100 unless request is canceled after equipment has already arrived at departure destination, in which case such fee shall then be the minimum charge for the transportation service.

6) **LIABILITY**

The carrier will not be liable for delays caused by and act of God, public enemy, authority of law, quarantine, riots, strikes, accidents, breakdowns, bad conditions of the road, storm, and other conditions beyond its control; and does not guarantee to arrive at or depart from any point at a specified time. The carrier will endeavor to maintain the schedule submitted by its agent or employee; and, over routes indicated but the same is not guaranteed.

If any act of God, public enemy, authority of law, quarantine, riots strikes, the hazards of dangers incident to the state of war, accidents, breakdowns, bad conditions of the carrier, inadvisable to operate its equipment either from point of origin or any point en route, the carrier will not be held for damages for any reason whatsoever.

FUEL SURCHARGE COST PRICE ADJUSTMENT

A fuel surcharge of 10% will apply on charter transportation charges when fuel cost price is over \$2.00 per gallon. On the 25th day of each calendar month, the price per gallon of diesel fuel will be determined based on the price stated by the U.S. Department of Energy, Energy information Administration's survey on "Retail On-highway Diesel Prices – West Coast Average". This price will be obtained by calling the DOE Fuel Hotline at (202)-586-6966.

The resulting charge is in addition to all other applicable transportation charges

The diesel fuel cost price adjustment will be shown separately from the charter revenue on carrier transportation documents for the purpose of identifying the amount as special fuel-related revenue.
