

**NTA FILING FEES AND PUBLICATION COSTS  
(Effective August 1, 2020)**

Nevada Revised Statutes, Chapter 706, and Nevada Administrative Code, Chapter 706, require the Nevada Transportation Authority (NTA) to collect filing fees and legal notice publication costs from applicants.

Below is the amount required at the time of filing for each type of filing. Once a filing is officially accepted, the application fee is non-refundable. Once a filing is submitted to a newspaper for publication, the amount paid for public notice is non-refundable.

Publication costs vary according to the type of application, geographical scope of authority requested, and whether a hearing is required, in accordance with the NTA's legal notice regulations. The amount paid at the time of filing for publication is a fixed estimate of the cost. Publication estimates are reviewed and updated quarterly.
