**NOTICE OF WORKSHOP TO
SOLICIT COMMENTS ON PROPOSED REGULATIONS**

The Nevada Transportation Authority (“Authority”) is proposing the adoption, amendment, and/or repeal of regulations pertaining to Nevada Administrative Code Chapter 706. A workshop has been set for **9:00 am on Tuesday, November 20, 2018**. The public may attend this workshop at the offices of the Nevada Business Center, located at 3300 W. Sahara, Nevada Room, Las Vegas, NV 89102 or 1755 East Plumb Lane, Suite #216, Reno, NV 89502. The purpose of this workshop is to determine impact of the proposed regulations on small businesses and to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations, including but not limited to:

- 1) Discuss potential changes to NAC 706.022, “‘Bus’ defined;”
- 2) Discuss potential changes to NAC 706.032, “‘Charter order’ defined;”
- 3) Discuss potential changes NAC 706.034, “‘Charter service by bus’ defined;”
- 4) Discuss potential changes NAC 706.080, “‘Livery vehicle defined;”
- 5) Discuss potential changes to NAC 706.036, “‘Charter Service by Limousine’ defined;”
- 6) Discuss potential changes to NAC 706.1015, “‘Prearranged’ defined;”
- 7) Discuss potential changes NAC 706.124, “‘Traditional Limousine defined;”
- 8) Discuss potential changes NAC 706.1377, “‘Certificate to provide intrastate charter service by bus;”
- 9) Discuss potential changes to NAC 706.191, “‘Insurance;”
- 10) Discuss potential changes NAC 706.210, “‘Lease of vehicle by common motor carrier for use as a traditional limousine or livery limousine vehicle;”
- 11) Discuss potential changes NAC 706.229, “‘Requirements for employee who drives traditional limousine or livery vehicle limousine;”
- 12) Discuss potential changes to NAC 706.147, “‘Provider of Free Shuttle service;”
- 13) Discuss potential changes NAC 706.379, “‘Inspection of vehicles by carrier;”
- 14) Discuss potential changes NAC 706.380, “‘Daily withdrawal of vehicles;”
- 15) Discuss potential changes NAC 706.381, “‘Inspection of vehicles by Authority;”
- 16) Discuss limitation to services to be provided by Charter Bus, and
- 17) Other matters related thereto.
