Luke O'Brien, O'Brien's Moving and Storage stated he was in favor of a fuel surcharge. Kenny Bissett, Carney Movers, stated his agreement and interest in holding a workshop. Russ Riggs, RA Two Men and a Truck, agreed and requested a Workshop be held. Crista Harris, O'Brien's moving and Storage, offered a statement in agreement. Applications Manager Liz Babcock indicated staff was in agreement with a fuel surcharge. A brief discussion ensued, the commissioners were in agreement with holding a workshop.

Commissioner Assad suggested the Legislature clarify the parameters for the Authority at the next session. Kimberly Maxson-Rushton, Esq. offered a statement regarding some of the historical issues the Authority has faced regarding NEMT's and offered several suggestions the Authority might take regarding possible legislation. James Kent, Esq. offered a statement in agreement with staff, questioned the current intervenor process and made several suggestions to streamline the application process. Brent Carson, Esq. offered the statement the NEMT's should be held to a higher standard as they transport public that is sick or injured and agreed with Commissioner Assad that the legislature should clarify for the Authority. Steve LaTulippe, Carevans, indicated the suggestions made to streamline the process are good ones.

Shawn Davis, Ashley's Towing, gave a statement regarding the history of Ashley's use of the Omadi software, indicated they have opted out of any updates and offered several points in favor of the use of the system. A discussion ensued with regard to the use of an exception report. Commissioner Groover stated the opinion these operators should be required to revert back to wet signatures until the system can be vetted. Mike Meyer, Omadi, stated the opinion the system could be tested within the next 30 days. Commissioner Assad felt it would be an over-burden to require the carriers to revert back to wet signatures. Robert Segura stated Omadi has become more robust as the software has improved. Several homeowner association managers gave positive statements regarding the use of the system. No action taken.
