- 6.** Pursuant to Governor Lombardo's Executive Order no. 2023-003, the Authority is proposing to modify existing regulations and potentially remove other existing regulations from the Nevada Administrative Code chapter 706. Consequently, this is an information gathering workshop to learn: (1) the industry stakeholders' response to the proposed changed/modified language of the identified regulations; (2) the industry stakeholders' response to the potential removal of the identified regulations; (3) of any other language changes the industry stakeholders' believe would be worthy of consideration; and, (4) of any other regulations which the industry stakeholder's feel should be considered for removal.

*Kimberly Maxson-Rushton, Esq. appeared on behalf of the Livery Operators Association, and detailed a list of recommendations for removal and suggestions for revision. (See Attachment 1) SB424*

*Bruce San Filippo, Quality Towing, stated the development of additional regulation has made it difficult for tow operators to conduct business efficiently and at a profit.*

*Michael Baumbach, President, Nevada State Tow Association, commented on NAC 706.203(4), the requirement of AVIR's. Mr. Baumbach then detailed the list of recommendations for revision that were submitted by the Nevada State Tow Association. (See Attachment 2)*

*Brian Hardy, Esq. representing several operators statewide, requested proposed regulation to incorporate electronic retention and maintenance of files. (See Attachment 3)*

*Brent Carson, Esq., requested the review of NAC 706.191 regarding carrier insurance requirements and limits.*

*Chairman Hartung indicated the final proposal must be submitted by May 1, 2023. Lucas Foletta, Esq. stated he would like to submit proposed language changes and would have his proposal to the Authority office by Tuesday, April 25, 2023. Ms. Rushton stated she would submit language regarding NAC 706.375 by end of business.*
