#### **DISCUSSION ITEMS**

83. **Docket 22-04002** Discussion regarding COVID rates, also known as sanitation or isolation fees, etc. and whether or not they are still needed or should be rescinded and the effect on current carriers that may have these rates in their tariff.  
*Applications Manager Liz Babcock summarized the procedural history of the docket. James Kent, Esq. appeared on behalf of Omni and detailed the process they used to get the sanitation fee approved. Brent*

*Carson, Esq. appeared on behalf of AWG and stated that the fee is part of the tariff and within that tariff he questioned what is considered “reasonable” and is the public willing to pay it. A lengthy discussion ensued with regard to a carrier’s ability to charge fees within their own tariff. Tommy Davis, GMT CARE, offered a statement regarding the difference between NEMT fees and other carrier fees. Motion to allow sanitation/isolation fees Approved 3-0*

*Applications Manager Liz Babcock summarized the procedural history of the Omadi system. Lucas Foletta, Esq. appeared in Reno on behalf of Milne Towing, offered a statement. Drew Ribar offered a statement. Adva Cohen, Fast Towing, is the only carrier granted with “conditions” and questioned the fairness of those conditions. Mike Myer, Omadi, appeared and offered a statement regarding the audit report or exception report Omadi has developed that the Authority would be able to access directly. Rene Revens, Chief of Compliance, detailed the concerns with the ability to manipulate data and that access needed to be granted by the existing carriers. Robert Segura, Titan Towing, offered several points regarding tow software. Zohar Garcia, Rescue Towing offered a statement in opposition to the Authority getting access to their Omadi system. Item tabled to the next subsequent Agenda Approved 3-0*

*Administrative Attorney Patricia Erickson detailed the item.*

*Commissioner Groover detailed the reasoning for his interpretation of the statute. Chairman Hartung offered the opinion that the statute is ambiguous and could be clarified. Rene Revens, Chief of Compliance stated several points to be considered in the driver permitting process such as a limitation on the number of carriers a driver can include on the application, three carriers maximum or limit to a corporate entity. She also indicated the need for a NAC for clarification for the carriers and staff. A discussion ensued with regard to processes, cost of reissue, replacement or updated card, time it takes staff to accomplish this task and the interpretation of NRS 706.462. Kimberly Maxson-Rushton, Esq. appearing on behalf of the Livery Operators Association, offered a statement citing several different factors that she feels should be considered in the driver permit process and suggested updated technology to assist in the process. Motion that driver permit is valid for 3 years, that permit can be updated without a fingerprint background check and that the current processing requirements remain the same. Approved 3-0*
87. **Docket 23-06011** – Discussion regarding the development of a Special Event policy including a change in how driver permits are issued for special events.  
*Commissioner Groover summarized the discussion item, the need for a policy and/or plan to be in place to assist staff and the possibility of holding a workshop to develop a NAC. He detailed the procedures he had researched previously. Chief of Compliance Rene Revens detailed the meetings she and Chief Park have attended with Formula 1 and the NFL committees, that the committee has developed a strategic plan and shared the information that has been exchanged and the cooperation they have offered. A discussion ensued with regard to general details for driver permitting and vehicle inspections. Chief Revens offered to update the Commissioners after each meeting with NFL or Formula 1 committees. Alan Waxler, AWG, offered several points regarding out of state buses, drivers and possible requirements for special events to increase fleet size for carriers. Kimberly Maxson-Rushton, Esq. appeared on behalf of the Livery Operators Association and also offered several points and suggested a Special Events Modification Application to assist the carriers to meet the transportation demand during these events. James Kent, Esq. echoed the previous comments and brought forward that any possible fees should be determined and made available to carriers as soon as possible. He also stated his agreement with Ms. Rushton with regard to a policy for a temporary increase in vehicles.*

*Administrative Attorney Patricia Erickson summarized the regulation, indicating the language is antiquated.*
