DISCUSSION ITEMS

93. **Docket 23-02026** Flywheel software program for approval to be used by Nevada certificated carriers. A representative of Flywheel will explain the specifics of the system as it applies to taxi and TNC functions running simultaneously. Flywheel was previously discussed at the March 16, 2023, general session but did not address the taxi and TNC application of the system and no vote was taken.

Kimberly Maxson-Rushton, Esq. and JJ Bell, appeared on behalf of Reno Ryde. Izzy Aala, CEO, appeared on behalf of Flywheel. Ms. Rushton detailed the program, Mr. Aala gave a demonstration. A discussion ensued with regard to how the driver would be compensated through the app, how Uber and the taxi company are compensated and the facilitation of tracking driver hours of service. Alex Larro, Uber, stated all rides would be considered taxi rides, Uber will price the trip, however, it is categorized as a taxi ride as Reno Ryde is facilitating the trip,

vehicle, insurance etc. It was determined this could only be operated with leased taxicabs. Applications Manager Liz Babcock stated the concept is a good one however she questioned whether the regulations would allow this type of transportation and compensation. Tony Clark, 24/7, offered the opinion the TNC regulations and the current carrier regulations would need to merge, but would the smaller carriers be left out. A suggestion was made that a pilot program be allowed and that further research be done into the application and the regulations governing it. Supervisor Craig Arnett suggested a workshop to allow Enforcement the ability to see how the system works and the issues enforcement may have.

Motion for approval of the Flywheel application for a one (1) year pilot program to utilize the simultaneous taxi/TNC software, after the initial start date of the program, with a 60 day report and a 3 month operational inspection – Approved 3-0

Motion to utilize Flywheel as a software-based taximeter program – Approved 3-0

Commissioner Groover detailed the discussion held at the Workshop for the use of virtual inspections by the Authority staff. Chief Revens stated that Staff was working on procedures that the rural certificated carriers may use to facilitate vehicle inspections and that TNC's may now utilize a virtual vehicle inspection. Chairman Hartung suggested a checklist that the carriers may use to verify the points the Authority will be inspecting. James Kent, Esq. questioned if the virtual inspection could be done at the point of origin. Chief Revens stated the valid AVIR would cover the initial inspection. A discussion ensued regarding when and where the virtual inspections would occur.

Motion to allow Authority staff the ability to utilize virtual inspections–Approved 3-0

Motion to allow TNC's the ability to utilize virtual inspections pursuant to NRS 706A.180 - Approved 3-0
